

दहा वर्षापूर्वी २०१३ मध्ये अल्पवयीन मुलगी घराबाहेर मैत्रिणीसोबत खेळत असताना आरोपीने तिच्यावर लैंगिक अत्याचार केला. या बाबत

मुलीच्या आईला माहिती मिळाल्यानंतर तिने पोलीस ठाण्यात तक्रार केली. पोलिसांनी आरोपी विरोधात पोक्सो कायद्यांतर्गत गुन्हा दाखल करून खटला दाखल केला. सत्र न्यायालयाच्या विशेष न्यायालयाने २०१७ मध्ये आरोपीला पोक्सो कायद्यांतर्गत दोषी ठरविले. मुलीच्या वडिलांनी आपल्याला वैयक्तिक कारणामुळे या खोट्या आरोपात अडकवल्याचा आरोपीचा दावा फेटाळून लावत पाच वर्षे सक्तमजुरीची शिक्षा ठोठावली. या शिक्षेविरोधात आरोपीने उच्च न्यायालयात अपील दाखल केले होते. त्यावर न्यायमूर्ती सारंग कोतवाल यांच्या समोर सुनावणी झाली. न्यायालयाने हे अपील फेटाळून लावताना सत्र न्यायालयाने ठोठावलेल्या शिक्षेवर शिक्कामोर्तब केले.

मुंबईतील फेरीवाल्यांसाठी नवे धोरण

सभासदांनी त्यांना मागील महिन्यात पसंती दाखवली. एक साखर कारखाना चालवणंही अनेक नेत्यांना जमत नसल्याचे गेल्या काही वर्षात दिसून आले आहे. अनेकदा शेतकऱ्यांची बिले तशीच अडकून राहतात. पण अभिजीत पाटलांनी पाच वर्षात पाच कारखाने चालवायला घेऊन शेतकऱ्यांनाही खूश केले होते. मात्र, आता आयकर विभागाने धाडी टाकल्याने पाटल यांच्या अडचणी वाढल्या आहेत.

भारतातील बहुतांश दूध उत्पादन हे छोटे शेतकरी करतात. सध्या उष्णता वाढल्याने गावांमध्ये पाण्याची कमतरता जाणवते. तसेच प्रदूषणाचीही मोठी समस्या आहे. राष्ट्रीय दुग्ध संशोधन केंद्राने ही समस्या सोडवण्यासाठी अभ्यास केला आहे. इथे मैशीची नवीन जात विकसित केली आहे. ही जात अन्य प्राण्यांपेक्षा अधिक उष्णता सहन करू शकते. असेच काही शास्त्रज्ञांनी जनावरांना बासरीचे संगीत ऐकवून त्यांचा तणाव शांत करण्याचा प्रयत्न केला. दूध देणारी जनावरे तणावमुक्त असणे गरजेचे आहे, असे डॉ. आशुतोष यांनी सांगितले.

झारखंडच्या मुख्यमंत्र्यांची कौडी

कारशेडची जागा जंगलात नाही
