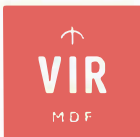

I, Ashish C. - 2) The Company had sent Postal Ballot Notice, along with explanatory statement under Section 102 of the Companies Act, 2013 on Tuesday, 06<sup>th</sup> December, 2022 by the electronic mode (email) to those Members whose email-IDs were registered in the records of the Registrar and Transfer Agent of the Company/ Depository Participant(s) as on Friday, 25<sup>th</sup> November, 2022, pursuant to aforementioned MCA Circulars. A copy of said Postal Ballot Notice was published on the website of the Company and NSDL.

- 3) In adherence to MCA Circulars, physical ballots were not dispatched, due to outbreak of COVID-19 Pandemic. Accordingly, the communication of the assent or dissent of the members had taken place through remote e-voting system only.
- 4) As per sub rule 3 of Rule 22 of the Rules and MCA Circulars, the Company published an advertisement on Wednesday, 07<sup>th</sup> December, 2022 about the dispatch of Postal Ballot Notice in 'Financial Express' (English and Gujarati - Ahmedabad Edition).
- 5) The members of the Company whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained by the depositories (in case of shares held in dematerialized form) as on the cut-off date i.e. Friday, 25<sup>th</sup> November, 2022 were entitled to avail the Remote E-voting facility, in respect of Resolution as set out in the Postal Ballot Notice.
- 6) In terms of Postal Ballot Notice the remote E-voting commenced on Wednesday, 07<sup>th</sup> December, 2022 (09:00 A.M. IST) and ended on Thursday, 05<sup>th</sup> January, 2023 (5:00 P.M. IST).
- 7) All votes cast through remote e-voting during the above mentioned period, were considered for scrutiny and at the end of Remote e-voting period, the Remote E-voting facility was blocked by NSDL forthwith.
- 8) After the conclusion of remote e-voting, the votes cast by the members through remote e-voting were unblocked on Thursday, 05<sup>th</sup> January, 2023 (5:00 P.M. IST) in the presence of two witnesses viz. Ms. Nirali Patel and Ms. Kinjal Raval who are not in employment of the Company. They have signed below in confirmation of the votes being unblocked.

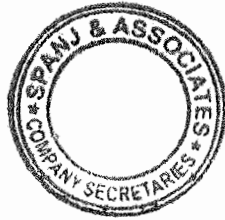
