PROCEEDINGS OF THE 39th ANNUAL GENERAL MEETING OF THE COMPANY

The 39th Annual General Meeting of the Company will be held on Monday, September 30, 2024 at 11.00 A.M at the registered office of the Company.

Mr. Arvind Gupta, Whole Time Director, welcomed the members to the 39th Annual General Meeting of the Company and introduced the Directors on the Dais.

Mrs. Pintu Chairperson of the Company chaired the proceedings of the Meeting.

The Chairperson declared that the requisite quorum was present.

The Chairperson declared that all the books and records required under the Companies Act, 2013 to be kept at the Annual General Meeting are available for inspection.

With the permission of the members, the Chairperson declared that the Notice convening the Meeting, having been circulated to the members to be taken as read.

The Chairperson then read out qualification, observations or comments on financial transactions or matters, which have adverse effects on the functioning of the company as mentioned in the Statutory and/or Secretarial auditors' report as specified under section 145 of the Companies Act, 2013. The Chairman then also mentioned that explanation of the management on the same has been mentioned in the Director's Report.

The Chairperson then delivered her speech. She explained the members the performance and various other operational aspects of the Company. The Chairperson answered all the queries raised by the Members and put the following items of business as per the Notice of AGM for approval by poll.

Mr. Arvind Gupta, Whole Time Director, informed that pursuant to Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 along with amendments thereto and Regulation 44 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 and Secretarial Standard- 2 issued by the Institute of Company Secretaries of India, the Company had provided facility for remote e-voting ("e-voting") to all the members as on the cut-off date of 23rd September 2024 through CDSL in respect of all the items to be transacted at this AGM. The remote evoting period was commenced on Friday, September 27, 2024 at 09:00 at A.M .and ends on Sunday September 29, 2024at 5:00 P.M.

Mr. CS. Hemanshu Upadhyay, Proprietor of M/S HRU & Associates, Practicing Company Secretary was appointed as Scrutinizer to conduct the poll in a fair and transparent manner and report on the results of the poll. The consolidated results of the poll and e-voting will be declared within 48 hours and it will be filed with Stock Exchanges and uploaded on the website of the Company and CDSL. In the usual course, the Members are requested to propose and second the Resolutions before the poll is taken on all the Resolutions.
