## Heavy rainfall in southern districts likely on Aug 8, 9: IMD

GUJARAT IS expected to witness heavy to moderate rainfall till August 12, India Meteorological Department (IMD) officials stated during a weather watch group meeting held at the State Emergency Operation Center (SEOC) Gandhinagar on Tuesday.

While south Gujarat districts, such as Surat, Navsari and Valsad, are expected to receive heavy rain on August 8, Banaskantha, Navsari and Valsad will witness heavy showers on August 9, said the weather department in its bulletin on Tuesday.

The monsoon situation and the preparation of all departments was reviewed and necessary guidance was given to concerned departments by the Additional Collector SEOC Kalpanaben Gadhvi during the meeting.

On Tuesday, Nizar in Tapi received the highest of 17 mm rainfall along with nearly 95 talukas that received light showers till 6 pm.

These included Sinor in Vadodara, Ankav in Anand, Vagra in Bharuch, Bhiloda in Aravalli, Dhanera in Banaskantha and Pardi in Valsad.

So far, the state has received 68 per cent average rainfall of the season.

## 'Don't panic, avoid rumours': GU to Bangladeshi students

AMID THE unrest in Bangladesh, the Gujarat University in Ahmedabad Tuesday urged its foreign students "not to panic" and "avoid reacting to rumours on social media" while issuing two emergency helpline numbers.

The varsity — one of the oldest and largest public universities in the state — has issued an advisory assuring full support to the foreign students who have been enrolled under the Study Abroad Programme (SAP).

Gujarat University Vice-Chancellor Dr Neerja Gupta and SAP director Nilam Panchal chaired a meeting with nearly 25 students from Bangladesh at the university's various programmes and other affiliated colleges under the Central government's Indian Council for Cultural Relations scholarship.

"Looking at the situation, we met the students and have issued an advisory to them. We have assured them that we are with them and they do not need to panic," Dr Gupta told *The Indian Express*.

According to the advisory, the Bangladeshi students have been asked not to leave Ahmedabad "without informing or seeking permission from concerned university authorities".

The students have also been asked to give an "emergency number" to the university.

"The students should avoid reacting to rumours or social media posts and stay calm," said the advisory.

The authorities have also issued "two 24X7 emergency helpline numbers on which the students can contact anytime".

Under the Study Abroad Programme, around 300 international students are enrolled under the ICCR scholarship majorly from Afghanistan, Bangladesh, Tajikistan, Sri Lanka and countries in the African continent.

According to the officials, nearly 25 Bangladeshi students are staying in the hostel for international students.

However, a few of the senior students are "living on their own as paying guest or rental accommodation" in the city, one of the international students shared on the condition of anonymity.

## Couple, son die by suicide in Morbi: Police

MORBI: A couple and their 19-year-old son allegedly died by suicide at their house in Morbi city Tuesday, police said.

Bodies of Haresh Kanbar (57), his wife Varshaben (55) and their son Harsh (19) were found hanging from the ceiling in different rooms of their flat, an official from A-division police station said.

"Prima facie, it appears to be a case of suicide. However, we are not ruling out other possibilities and will investigate the case from all angles," said SP Rahul Tripathi.

A note was recovered from the spot in which the family said that no one should be held responsible for the deaths, he said, adding a probe is on into the case. PTI

## 53 Chandipura cases reported in country, Gujarat tops list: Nadda tells Rajya Sabha

INDIA HAS reported 53 confirmed cases of Chandipura virus — 51 from Gujarat and two from Rajasthan — as on July 31, Union Health Minister J P Nadda told the Rajya Sabha Tuesday.

Of these 53 cases, 19 people have died and all deaths have been reported from Gujarat, Nadda said in a written response to a question.

Elaborating on the steps taken to prevent the outbreak of the virus, Nadda said a National Joint Outbreak Response Team (NJORT) has been deployed to assist the Gujarat government for undertaking public health measures and for detailed epidemiological investigation into the outbreak.

Experts from the Integrated Disease Surveillance Program, National Centre for Disease Control, Indian Council of Medical Research and National

Institute of Virology Pune are part of the NJORT, Nadda said.

A team from the NCDC, Delhi, and ICMR NIV Pune is undertaking an epidemiological investigation into the Acute Encephalitis cases and related deaths.

Besides, entomologists from National Centre for Disease Control (NCDC) are stationed at the affected areas.

Health rapid response teams and Accredited Social Health Activists and Auxiliary Nurse and Midwives have conducted

surveillance for early identification of cases and timely referral of suspected cases to the nearby hospitals and medical colleges which are offering 24 hours services and ventilator support.

Nadda said indoor residual spraying for control of the vector (sandfly) has been intensified in the areas from where cases have been reported.

"The Government is closely monitoring and reviewing the situation in coordination with state government," he stated.
