

'गुगल'च्या इशाराच्या पंतप्रधान स्कॉट मॉरिसन यांनी तातडीने प्रत्युत्तर दिले आहे. तुम्ही आमच्या जागेत काय करणार याचा निर्णय ऑस्ट्रेलिया सरकार घेणार, आमची संसद घेणार. ऑस्ट्रेलियात कायकाज असेच चालते, असे मॉरिसन यांनी स्पष्ट केले. येथील अनेक संस्थांनीही, सरकारने आपल्या भूमिकेवर ठाम राहिले, असा आग्रह धरला आहे.

ब्रिटन सरकारचा भरपाई देण्याचा विचार

'पॉझिटिव्ह'ना दिलासा

लंडन, ता. २२ : कोरोनाचाचर्चात पॉझिटिव्ह आढळल्यास घरी बसावे लागण्याने आर्थिक नुकसान होण्याची लोकांच्या मनातील भीती घालविण्यासाठी त्यांना विशिष्ट रकम भरपाई म्हणून देण्याचा विचार ब्रिटनचे सरकार करत आहे. यासाठी महिन्याला दोन अब्ज पाँड इतकी तरतूद करावी लागेल. तसे धोरण लवकरच जाहीर होण्याची शक्यता आहे.

सहकार्यास नकारामुळेच...

कोरोनाचाचर्चा करून घेण्यास किंवा लॉकडाऊनच्या नियमांचे पालन करण्यास नकार देण्याचे प्रमाण बरेच वाढते आहे. त्यामुळे विविध वातावरण निर्माण झाले आहे. अशावेळी सरकारमधील काही अधिकार्यांनी ही सूचना केली आहे.

लसीमुळेच मृत्यू झाल्याचा पुरावा नाही

न्युयॉर्क, ता. २२ : नॉर्वेमध्ये फायझरची लस टोचल्यानंतर काही जणांचा मृत्यू होण्याची भीतीदायक घटना घडली असली तरी, जागतिक आरोग्य संघटनेने (डब्ल्यूएचओ) सुरक्षिततेबाबत निर्वाळा दिला आहे. त्या व्यक्तींचा मृत्यू लसीमुळे झाल्याचा कोणताही पुरावा मिळाला नसल्याचे त्यांनी स्पष्ट केले आहे. लसीचा सुरक्षिततेबाबत डब्ल्यूएचओच्या जागतिक सल्लागार समितीने शुक्रवारी एक निवेदन जारी केले. या समितीची मांडवारी आढावा बैठक झाली. या निवेदानुसार काही जणांच्या मृत्यूंसारखे वृत्त अंशिक होते. सर्व प्रकारच्या कारणांमुळे होणारे मृत्यूही गृहीत धरवे लागतात. मोठ्या लोकांसंख्येच्या भागातील अशाच, जास्त वयाच्या व्यक्तींच्या मृत्यूची कारणेही लक्षात घ्यावी लागतात. याशिवाय उपलब्ध माहितीवरून मृत्यूच्या घटनांमधील लसीच्या कारणाने दुसरा मिळालेला नाही.

मास्क नसल्यास पत्रास पुश-अपसची शिक्षा

डेनपार (इंडोनेशिया), ता. २२ : जगातील आघाडीचे पर्यटन केंद्र मानल्या जाणाऱ्या बालीतील प्रशासनाने फेस मास्कच्या उपायाची अंमलबजावणी व्हावी म्हणून शक्य लढविली आहे. मास्क नसल्यास, असून न घालणाऱ्या, दंड भरण्याची रकम नसलेल्या अशा बेफिकरी परदेशी पर्यटकांना पुश-अपस काढण्याची शिक्षा केली जात आहे. बाली वेस्टव्हर दरवर्षी जगभरात हजारो पर्यटक येतात. नव्या वनात पर्यटकांचा प्रतिसाद वाढतो आहे. या उष्णकटिबंधीय प्रदेशात सध्या उकाडा वाढला आहे. यानंतरही सुरक्षा अधिकारी या उपायाची काटेकोर अंमलबजावणी करत आहेत. टी-शर्ट आणि शॉर्ट घातलेले पर्यटक पुश-अपस काढताताने व्हिडिओ व्हायरल झाले आहेत. येथील प्रशासनाने गेल्याच वर्षी सार्वजनिक ठिकाणी मास्कचा सक्ती केली होती. गेल्या काही दिवसांत असंख्य परदेशी पर्यटक मास्कविना फिरत असल्याचे आढळून येत आहे, असे सशस्त्र अधिकारी पुस्तो आरुंगू केतू सुचनिगारा यांनी सांगितले. काही स्थानिक नागरिकांनीही या शिक्षेला सामोरे जावे लागले आहे.

कोरोनाविरोधात अमेरिकेचे रणशिंग

'शंभर दिवसांची मोहीम' जाहीर; मास्क अनिवार्य वॉशिंग्टन, ता. २२ (पीटीआय) : कोरोनाविरोधातील लढाईला बळ देण्याचा निश्चय केलेले अमेरिकेचे नवे अध्यक्ष ज्यो बायडेन यांनी आज युद्धपातळीवरील धोरण जाहीर केले. यानुसार, मास्क चालणे अनिवार्य करण्यात आले असून परदेशींना येणाऱ्यांना विलगीकरण कालावधी झाल्यानंतरही कोरोना चाचणी अत्यावश्यक करण्यात आली आहे. ज्यो बायडेन यांनी आणि विलगीकरण झाल्यावर कोरोना चाचणी करणे दिवसांत दोस पावले उचलण्याचे आश्वासन दिले होते. त्यानुसार त्यांनी आज नवीन आदेशांवर सही केली. कोरोना संकटातून बाहेर पडण्यास अमेरिकेला काही महिने लागतील, मात्र यातून निश्चितपणे बाहेर पडू, असा विश्वास बायडेन यांनी व्यक्त केला. नवीन धोरणानुसार, मास्क घालण्याबरोबरच अमेरिकेत येणाऱ्या विमानात बसण्यापूर्वी, अमेरिकेतून बाहेर जाण्यापूर्वी आणि विलगीकरण झाल्यावर कोरोना चाचणी करणे बंधनकारक आहे.

भारताबरोबर संबंध दृढ होतील

वॉशिंग्टन (पीटीआय) : कमला हॅरिस यांच्या हाती उपाध्यक्षपदाची सूत्रे गेल्यामुळे अमेरिका आणि भारत यांच्यातील संबंधांना अधिक महत्त्व आहे, असे 'व्हाइट हाऊस'च्या एका वरिष्ठ अधिकार्याने आज सांगितले. कमला हॅरिस या अमेरिकेच्या पहिल्या भारतीय वंशाच्या उपाध्यक्ष आहेत. कमला हॅरिस (वय ५६) यांचे वडिल जमकाचे, तर आई भारतीय आहे. आज पत्रकार परिषदेत बोलताना 'व्हाइट हाऊस'च्या माध्यम सचिव जेन साकी यांनी सांगितले की, भारत आणि अमेरिकेतील दीर्घकालीन संबंधांचा अर्थ असा होतो की बायडेन यांना आदर आहे. बायडेन यांनी भारताला अनेक वेळा भेटही दिली आहे. आता भारतीय वंशाच्या हॅरिस या उपाध्यक्षपदी आल्याने हे संबंध आणखी दृढ होण्यास मदत होणार आहे. कमला हॅरिस यांनीही पत्रकारांशी बोलताना आपल्या आईचा उल्लेख करत, तिच्या शिकवणीमुळेच आपण ही मजल मारल्याचे अभिमानाने सांगितले होते.

अण्वस्त्रबंदीसाठी पहिला करार लागू

जोन्सव्ह, ता. २२ (वृत्तसंस्था) : अण्वस्त्रबंदी बंदी घालणारा पहिलावहिला करार शुक्रवारी लागू झाला. हे ऐतिहासिक पाऊल मानले जात असले तरी त्यात अण्वस्त्रधारी देश तसेच नाटो राष्ट्रांची समावेश नाही. हा करार आता आंतरराष्ट्रीय कायद्याचा भाग बनला आहे. जुलै २०१७ मध्ये तसा प्रस्ताव संयुक्त राष्ट्रांच्या आमसभेत मांडण्यात आला तेव्हा १२० देशांनी मान्यता दिली. अमेरिका, रशिया, ब्रिटन, चीन, फ्रान्स, भारत, पाकिस्तान, उत्तर कोरिया आणि इस्राईल या नऊ देशांकडे अण्वस्त्र असल्याचे मानले जाते. त्यापैकी कुणीही त्यास पाठिंबा दिला नाही. याशिवाय नाटो समूहातील ३० देशांनीही मंजुरी दिली नाही.

आणखी एक उल्लेखनीय बाब म्हणजे दुसऱ्या महायुद्धात अणुबाँब हल्ल्यामुळे अपभ्रंशित हानी झालेल्या जपानचाही यास पाठिंबा नाही.
