A] The Company had allotted 40,28,252 Equity Shares to the Shareholders of Chordia Food Products Limited (CFPL) on 4th August, 2022 on Demerger of Food Division of CFPL into the Company. The said Equity shares were listed on BSE Ltd. w.e.f. 6th October, 2022. As such, although the period covered for this certificate is for the FY 1st April, 2022 to 31st March, 2023 the actual data pertains to the period commencing from the Listing of the Equity Shares.

The shareholders who were holding Equity Shares in CFPL in Physical mode were allotted Shares in the Company in Demat Mode and the same were credited to 'M/s Aveer Foods Limited- Physical Unclaimed Securities Escrow Account' and hence, there are no shareholders holding shares in physical mode

B] As all the Equity Shares are in Demat form, there were no Share Transfer requests received / effected during the period from 1st April, 2022 to 31st March, 2023 as examined from the aforesaid records of the Company and RTA Agents.


