JUNE 2, 1936 – OCTOBER 31, 2022

Padma Bhushan Dr Jamshed J Irani (Former Director of Tata Sons and Managing Director, Tata Steel) left for his heavenly abode on October 31, 2022 at 10:00 pm. He will be fondly remembered for leading Tata Steel from the front during India's economic liberalisation in the 1990s. He was amongst the first leaders of the 'Quality Movement' in India.

Dr Irani was conferred an Honorary Knighthood (KBE) in 1997. He received the Padma Bhushan in 2007 for his contributions in the field of trade and industry.
