Gurugram, January 25, 2019: The Board of Directors of JTEKT India Ltd (Formerly Known as Sona Koyo Steering Systems Ltd.), India's largest manufacturer and supplier of Steering Systems, in its meeting held on 25th January, 2019 has taken on record the unaudited Financial Results for the guarter ended 31st December 18.

Standalone

For the quarter ended 31st December 2018, Net Revenue has increased by 1.61% to Rs. 297.52 Crores as compared to Rs. 292.80 Crores of the corresponding year. Profit after Tax increased by 8.45% to Rs. 5.77 Crores against Profit of Rs. 5.32 Crores of the corresponding quarter.

For the nine months ended 31st December 2018, Net Revenue has increased by 6.65% to Rs. 947.95 Crores as compared to Rs. 927.43 Crores of the corresponding year. Profit after Tax increased by 45.21% to Rs. 23.80 Crores against Profit of Rs. 16.39 Crores of the corresponding year excluding dividend from subsidiary of Rs 9.87 Crores.
