Pursuant to Regulation 30 and in accordance with clause 20(b) of Para A of Part A of Schedule III the Listing Regulations read with circular dated July 13, 2023 issued by SEBI, we would like to inform that the Company has received the Order dated 18<sup>th</sup> January, 2024 on 31<sup>st</sup> January, 2024 at 2:10 p.m. (IST), in relation to the Adjudication Proceedings conducted by the Directorate General of GST Intelligence, under the Central Excise Act, 1944 for the period starting from financial year 2014-2015 to financial year 2017-18 and imposed a penalty of INR 6,08,264 (Rupees Six Lakhs Eight thousand two hundred & Sixty Four only) on the Company under section 11AC (1) (C) of the Central Excise Act, 1944.

The Company may challenge this Order in appeal on the basis the legal advice. The Company does not reasonably expect the Order to have any material financial impact.
