

सरकारी स्कूलों की दशा काफी खराब है। स्कूल बिल्डिंग जर्जर हालत में हैं। खस्ताहाल कमरों में विद्यार्थियों को पढ़ाया जा रहा है, जिससे कभी भी कोई बड़ा हादसा हो सकता है। इसके अलावा सरकारी स्कूलों में सभी जरूरी संसाधन पीने का पानी, शौचालय, प्रयोगशाला, खेल का मैदान, कंप्यूटर लैब आदि की व्यवस्था ठीक नहीं है। स्कूलों में कमरों व अध्यापकों की काफी कमी है, जिसके कारण सरकारी स्कूलों की ओर अभिभावकों का आकर्षण बहुत कम है। अभिभावक मजबूरी में अपने बच्चों को प्राइवेट स्कूलों की मनमानी फीस को सहन करके प्राइवेट स्कूलों में पढ़ा रहे हैं।
