QUORUM OF THE MEETING:

A total of 79 members (holding 9,49,47,780 equity shares) attended the 76th AGM.

The meeting commenced at 10:00 a.m. (IST) and concluded at 11.08 a.m. (IST).

Mr. Anil Singhvi chaired the meeting. The Chairman informed that this annual general meeting is being held through video conference and other audio-visual means in accordance with the circulars issued by the Ministry of Corporate Affairs and SEBI. The requisite quorum being present, the Chairman called the meeting to order. All the Directors of the Company attended the meeting. The Chairman welcomed all shareholders, auditors and other invitees joining over VC and delivered his speech. The Chairman informed that the Company had provided members the facility to cast their vote electronically, on all resolutions set forth in the Notice. It was further informed that there would be no voting by show of hands. Mr. Suresh Meher, Company Secretary, briefed the Members about the guidelines for participation by Members and speakers registered for the AGM and voting process during the AGM.

The following items of business, as per the Notice of AGM dated 28th April, 2021, were transacted at the meeting. Shareholders were provided a facility to ask questions or express their views as speakers through VC /OAVM during AGM. Shareholders were also given opportunities to ask questions or express their views, through Company's Investors Service Center Email, prior to AGM. Answers and Clarifications were provided by Chairman to the queries raised by the members. The resolutions were passed with the requisite majority.
