Investors shall submit form ISR-1 for updating PAN and other KYC details. Please note that in case you have already a DEMAT A/c, you may also send your Client Master List (CML) and the RTA shall update your folio with the information on 1) Present Address, 2) Bank Details, 3) E-mail address and 4) Mobile number from the details available in the CML.

In case of mismatch of signature or no signature with RTA, the investor shall furnish original cancelled cheque and banker's attestation of the signature as per form ISR-2.

Investors shall mandatorily register nominations with RTA and use form SH-13 and SH-14 for declaration of nomination and change in nomination respectively. However, in case investor wants to opt-out of nomination, form ISR-3 shall be filed.

Investors are requested to ensure that the above details are updated with RTA before October 1, 2023, since folios for which the above details will not be available shall be frozen thereafter.
