सध्या मुंबईत १० टक्के पाणी कपात आहे. मात्र त्यामुळे काही भागात अजिबात पाणी येत नाही. तर काही भागात अतिशय कमी दाबाने पाणी येते. त्यामुळे लोकांमध्ये प्रचंड संताप आहे. पाणी पुरवठ्यासाठी ट्रॅकरची मागणीही वाढली आहे. त्यामुळे पाणी कपात वाढवण्याचा सध्या विचार नसल्याची माहिती पालिकेच्या वरिष्ठ अधिकार्यांनी दिली.

अधिकधिक काळ उपयोगात यावा यादृष्टीने खबरदारीचा उपाय म्हणून तोंडशी अशा सातही धरणातील पाणीसाठा कमी होत असून बुधवारी हा पाणीसाठा ५.२८ टक्के होता. हा पाणीसाठा गेल्या तीन वर्षातील सर्वात कमी आहे. धरणांमधील पाणीसाठ्यात घट झाल्याने हा साठा

सध्याची पाणीस्थिती

मुंबईला पाणीपुरवठा करणाऱ्या सातही धरणात मिळून ७६ हजार ४२९ दशलक्षलीटर म्हणजेच ५.२८ टक्के पाणीसाठा आहे. गेल्यावर्षी २०२३ मध्ये २५ जून रोजी पाणीसाठा ६.५७ टक्के होता तर त्यापूर्वी पाणीसाठा ९.३४ टक्के होता. मुंबईला दर दिवशी ३८०० दशलक्षलीटर पाण्याचा पुरवठा केला जातो. राज्य सरकारने मुंबई महानगरपालिकेला राखीव साठा वापरण्यास परवानगी दिली आहे. त्यानुसार राखीव साठ्याचे पाणी उपलब्ध झाले आहे. हे पाणी जुलै महिना अखेरपर्यंत पुरवावे लागणार आहे.

पाणीसाठ्याची स्थिती गंभीर बनली आहे. जून महिन्यात पुरेसा पाऊस पडेल, असा अंदाज हवामान खात्याने वर्तवला होता. मात्र पुरेसा पाऊस पडलेला नाही. जून महिनाही आता संपत आला असून पावसाला पुरेशी सुरुवात न झाल्यामुळे चिंता वाढली आहे.

नवीन फौजदारी कायदे समजण्यासाठी 'संकलन ऑप'

कायद्यात नेमके काय बदलणार?

नागपूर: १ जुलैपासून देशात भारतीय न्याय संहिता (एनबीएस-२०२३), भारतीय नागरिक सुरक्षा संहिता (बीएनएसएस-२०२३) आणि भारतीय साक्ष अधिनियम (बीएसए) असे तीन नवे फौजदारी कायदे लागू होणार आहेत. हे कायदे ब्रिटिशकालीन भारतीय दंड संहिता (आयपीसी), फौजदारी प्रक्रिया संहिता (सीआरपीसी) आणि भारतीय पुरावा कायद्याची जाणा घेणार आहेत. या बदलादरम्यान संभ्रम निर्माण होऊ नये म्हणून नॅशनल क्राइम रिकॉर्ड ब्युरोने (एनसीआरबी) 'संकलन' हे विशेष 'ऑप' तयार केले आहे. याद्वारे सहजरीत्या नव्या आणि जुन्या कायद्यातील तरतुदींचा तुलनात्मक अभ्यास करता येतो.

नवीन भारतीय नागरिक सुरक्षा संहितेत ५३३ कलमे आहेत. यात नऊ कलमे वाढवण्यात आली तर १६० कलमांमध्ये बदल करण्यात आला आहे. भारतीय दंड संहिता कायदा बदलण्यासाठी आणलेल्या भारतीय न्याय संहिता विधेयकात ३५६ कलमांचा समावेश आहे. आधीच्या कायद्यातील १७५ कलमे वाढवण्यात आली, तर २२ कलमे रद्दबातल करण्यात आली आहेत. भारतीय साक्ष कायदात १७० कलमे आहेत.

शिबीर घेण्यात येत आहेत. याच पार्श्वभूमीवर 'एनसीआरबी'ने संकलन 'ऑप' तयार केले आहे. 'गूगल प्लेस्टोर', 'अपल स्टोर' वर ते मोफत उपलब्ध आहे. 'ऑप'मध्ये नवीन फौजदारी कायद्यांसाठी तीन स्वतंत्र भाग आहेत.

देशातील निम्म्या प्रौढांमध्ये तंदुरुस्तीचा अभाव

भारतात २०२२ या वर्षी जवळपास ५० टक्के प्रौढ व्यक्ती शारीरिक हालचाली करण्यात असल्याचे एका अभ्यासातून समोर आले आहे. 'लॅसेट ग्लोबल हेल्थ जर्नल'मध्ये हा अभ्यास प्रकाशित करण्यात आला आहे. संपूर्ण दक्षिण आशियाई प्रदेशाचा आढावा घेतल्यास भारतात पुरुषांच्या तुलनेत (४२ टक्के) स्त्रिया (५७ टक्के) सर्वाधिक शारीरिकदृष्ट्या सुस्त असल्याचे आढळून आले आहे. यात महिलांमध्ये शारीरिक हालचालीची अपुरी पातळी पुरुषांच्या तुलनेत सरासरी १४ टक्क्यांनी जास्त आढळली.



अधिक उत्पन्न असलेल्या आशिया पॅसिफिक प्रदेशांनंतर प्रौढ व्यक्ती शारीरिकदृष्ट्या सक्रिय नसण्याच्या बाबतीत दक्षिण आशियाई प्रदेश दुसऱ्या क्रमांकावर आहे, असे जागतिक आरोग्य संघटनेच्या (डब्ल्यूचओ) संशोधकांच्या आंतरराष्ट्रीय पथकाने म्हटले आहे. जागतिक स्तरावर सुमारे एक तृतीयांश प्रौढ (३१.३ टक्के) सुस्त होते, असेही संशोधकांनी म्हटले. यामध्ये दर आठवड्याला किमान १५० मिनिटे मध्यम-तीव्रतेची किंवा अधिक आठवड्याला ७५ मिनिटे अधिक तीव्रतेची शारीरिक क्रिया करत नसलेल्या प्रौढांचा समावेश होतो.

२०१० मध्ये जगभरातील २६.४ टक्के प्रौढ व्यक्ती शारीरिक हालचालींमध्ये असक्रिय होते, ते आता पाच टक्क्यांनी वाढले आहे. जर २०१०-२२ चा हा कल असाच कायम राहिल्यास शारीरिक हालचालीमध्ये १५ टक्क्यांनी सुधारणा करण्याचे जागतिक लक्ष्य गाठले जाणार नसल्याचे अहवालात म्हटले आहे. भारतात २००० या
