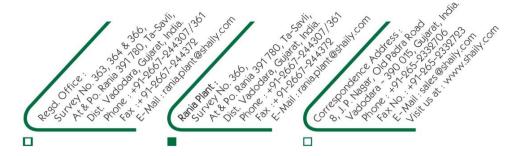

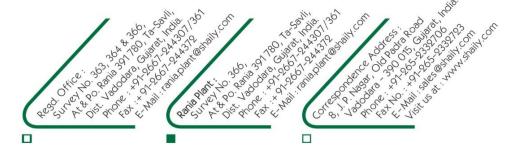
This is to inform you that the Board of Directors of the Company in their meeting held on **Monday**, **May 30**, **2022**, inter alia, transacted the following business:

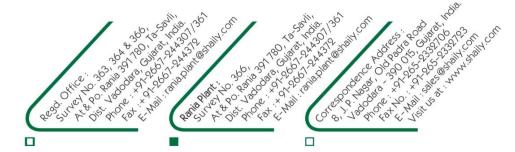

Mr. Samaresh holds a PGDM from IIM -Ahmedabad, with additional qualifications as a Chartered Accountant and a Cost Accountant.

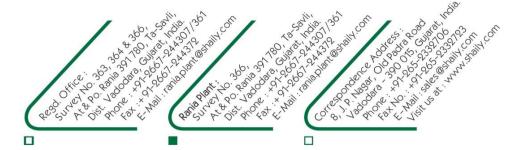

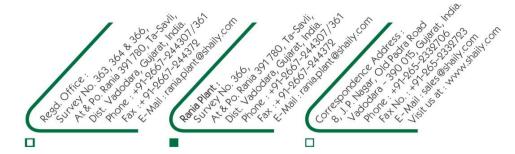
