 - d. Rights Issue Price: Rs. 10/- per Rights Equity Share (at par).
 - e. Designated Stock Exchange:
 BSE Limited shall be the Designated Stock Exchange.
- 3. The record date, rights issue opening and closing date shall be approved at a meeting to be held on a subsequent date.
- 4. The Board hereby authorizes Mr. Darshak Mahesh Rupani and/or Mr. Prashantt Mahesh Rupani, Directors of the Company to incorporate the above terms of the Issue in the Letter of Offer and other relevant forms/ documents and the same shall be approved at a meeting to be held on a subsequent date.
