एक आधिकारिक दस्तावेज के मुताबिक प्रदेश में तत्कालीन सूचना के अधिकार (आरटीआइ) अधिनियम के तहत जम्म कश्मीर राज्य सूचना आयोग के समक्ष सुनवाई के लिए लंबित सभी दुसरी अपीलों और शिकायतों का निस्तारण अब केंद्रीय सुचना आयोग (सीआइसी) द्वारा किया जाएगा।

जम्मू कश्मीर राज्य को 31 अक्तूबर 2019 को दो केंद्र शासित क्षेत्रों– जम्मृ और कश्मीर तथा लद्दाख– में विभाजित किए जाने के बाद यह कदम उठाया गया है।

जम्मू–कश्मीर सूचना का अधिकार अधिनियम, 2009 के तहत बड़ी संख्या में दिए गए आवेदन और अपीलें विभाजन के वक्त लंबित थीं। दो केंद्र शासित क्षेत्रों के बनने के बाद से नागरिक और आरटीआइ कार्यकर्ता वकीलों और अन्य अधिकारियों से इस बारे में स्पष्टता के लिए संपर्क कर रहे थे कि उनके आवेदनों का निस्तारण कैसे होगा, खासकर तब जब पहली अपील विभिन्न सार्वजनिक प्राधिकरणों और दूसरी अपील और शिकायतें राज्य सुचना आयोग के समक्ष लंबित हैं। कार्यकर्ताओं का कहना है कि केंद्रीय आरटीआइ अधिनियम के तहत केंद्र शासित क्षेत्रों के पास सूचना आयोग बनाने का अधिकार नहीं है।
