CHOLAMANDALAM **INVESTMENT AND** Finance Company (Chola), the financial services arm of Murugappa group, has said that it expects a 20% growth in its asset under management (AUM) for FY24.

The company believes that it can grow more than the industry in the auto loan segment. It is also looking to alter the product mix in the overall disbursement portfolio, with plans to bring down the AUM share of vehicle finance from the current 62% to 50% in another two to three years.

Subsequently, the share of other products such as loan against property (LAP) and housing loans will move up to 35% from the current 28%. NEW UNIT WILL COME UP IN TAMIL NADU

Mitsubishi to set up ₹1.8K cr plant

ELECTRONIC JAPANESE EQUIPMENT manufacturer Mitsubishi Electric is setting up a new manufacturing unit in Tamil Nadu at an investment of about Rs 1,891 crore for which the foundation stone was laid by the state chief minister M K Stalin on Tuesday. The manufacturing facility

60% would comprise women employees, the company said. The factory would implement various initiatives for carbon neutrality including minimization of carbon dioxide emissions through enhanced thermal insulation, use of highly efficient air-conditioning and heated water systems.

The company officials said the commercial production at the facility was expected to begin in October 2025 and the initial capacity of room air-conditioners would be three lakh units and 6.50 lakh for compressors by December 2025. The manufacturing unit would meet sustainable development goals through measures such as reusing waste water through underground filtration treatment and site greening, the company said. Tamil Nadu had garnered ₹2,73,448 lakh crore worth of investments by signing 224 memorandum of understandings with companies after the government assumed office in May 2021. The MoUs would generate 4,10,561 new jobs.Speaking at the foundation stone laying ceremony of Mitsubishi Electric, chief minister Stalin said to attract investors for the Global Investors Meet in January 2024, he would be undertaking a visit to Japan and Singapore on May 23.

DS Group forays into chocolate segment

FMCG COMPANY DHARAM-PAL Satyapal Group (DS Group) has forayed into chocolates to add to its portfolio of confectionaries, beverages, spices, mouth fresheners and hospital-

According to Rajiv Kumar, vice-president of DS Group, they have a premium chocolate brand and are preparing to enter the mass segment chocolate industry soon, giving them a presence across the board in the chocolate business. The company has diversified

from tobacco into other products and at present only 10% of the revenues come from tobacco products, Khanna said. The DS group was in talks with Swiss chocolate maker Laderach since 2019, but Covid disruptions delayed the process. Talks resumed post-Covid, resulting in an agreement in March 2023 to be the exclusive franchise partner of Laderach in India, Kumar said.

The company has diversified away from tobacco and now generates only 10% of its

in price ranges ranging from '1,050 to '12,940 depending on taste and package size. However, Kumar is confident of a developing market for these premium chocolates in the country. The brand has been exposed to Indians travelling to Singapore, Dubai, and other nations. "The ultra-rich grew by 11 times in

to premium chocolates and they want the world's best chocolates. They can now get fresh chocolates here instead of carrying them from outside," Kumar said. These chocolates would be available at the companyowned boutique which would be located in premium locations. The first store will open in Delhi in two to three months. It would be a steady expansion, with 5-7 locations across the country opening within the next one to two years.

It would be a gradual ramp up and in the next one to two years have 5-7 stores across the country. A shop-in-shop concept will also be added later. DS is set-

ting up cold chains to distribute chocolates across the country to maintain a temperature of 18-20 degrees. The company has already started selling online on the company's own e-commerce platform which has started receiving bulk orders for corporate gifting, marriages and baby showers with luxury chocolates replacing Indian sweets. DS Group would soon start an advertising and marketing campaign across media. Theywould be focused on creating awareness and brand equity for the first two to three years and would not be looking at either the top line or bottom

According to Kumar India's per capita consumption of chocolates was 140 grams while globally it was 900 grams per person while European consumption per person per annum was 8-12 kg. He is confident that the brand will do well in India both in terms of top line and bottom line. The IMARC Group has estimated the Indian chocolate market was worth \$ 2.4 billion in 2022 and was expected to reach \$4.1 billion by 2028.

Army to adopt common uniform for Brigadiers and above from August 1

AMRITA NAYAK DUTTA New Delhi, May 9

IN A MOVE that seeks to establish a common identity for the Army's senior leadership, all officers of the rank of Brigadier and above will wear the same uniform from August 1 this year, irrespective of their parent cadre and appointment.

This ends the long-standing practice of officers donning different uniform and accoutrements reflecting various arms, regiments and services in the Army.

For instance, officers of the parachute regiment wear a maroon beret,

that the common uniform will comprise dark green beret, single-piece belt with the Indian Army insignia on the buckle, and brass rank badges. The officers are also likely to wear a peak cap as part of their ceremonial dress, instead of hats donned by officers of certain regiments.

According to sources, the decision was taken after detailed deliberations during the recent Army Commanders Conference and extensive consultations with all stakeholders.

The change, however, will not affect the uniform worn by officers of the rank of Colonel and below.

Explaining the reason, sources said this recognition with distinct identity within the arms or regiment or services is essential for the junior leadership and the rank and file, to further strengthen camaraderie, esprit de corps and regimental ethos which is the bedrock of soldiering.

"At the unit or battalion level, a distinct sense of identity reflects a strong bond among officers and men in the same regiment," a defence source said.

However, officers of the rank of Brigadier and above would have completed appointments where they command units or battalions, and would be posted at headquarters or other establishments where officers from all arms and services work together.

The process to ensure a common uniform for all flag-rank officers is being implemented in two stages. In 2021, the mess dress for all officers of the rank of Brigadier and above was made common.

Side caps and cummerbund, which were earlier of different colours, were made a common black, and the backing was removed from rank badges.

Sources said the latest change was planned to be implemented last year, and extensive deliberations were held by the Army's top brass. However, there was a difference in opinion on

whether the beret should be dark

green or black.

The decision, said sources, will also reinforce the Indian Army's character as a fair and equitable organisation. A standard uniform, they said, will ensure a common identity for all senior-rank officers, while "reflecting the true ethos of the Indian Army."


