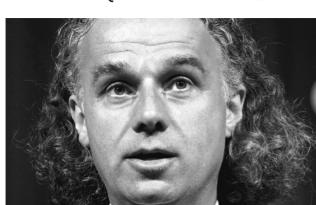
विदेशी निवेशक भारतीय इक्विटी में नए निवेश से पहले अप्रैल-मई में होने वाले आम चुनाव के नतीजों का इंतजार कर सकते हैं

नई दिल्ली, 15 फरवरी

एलएसए के प्रबंध निदेशक और इक्विटी रणनीतिकार क्रिस वड ने साप्ताहिक न्यजलेटर ग्रीड ऐंड फियर में लिखा है कि भारतीय इक्विटी में नए निवेश से पहले विदेशी निवेशक अप्रैल-मई 2019 में होने वाले आम चुनाव के नतीजे का इंतजार कर सकते हैं।

उन्होंने कहा, भारत में बॉन्ड व मुद्रा बाजार राजकोषीय नरमी से बेफिक्र नजर आए क्योंकि वित्त वर्ष 2018-19 के पहले नौ महीने में कर संग्रह साल दर साल के हिसाब से महज 7 फीसदी बढ़ा। उनके मुताबिक, निवेशक यह मानकर चल रहे हैं कि लोकल्भावन कदम अल्पावधि में देखने को मिल सकते हैं, अगर इससे नरेंद्र मोदी को अप्रैल-मई के आम चनाव में दोबारा जीतने में मदद मिलती हो।

मुंबई, 15 फरवरी

वेंचमार्क सूचकांकों में लगातार सातवें दिन गिरावट जारी रही। इस हफ्ते बेंचमार्क सूचकांकों ने 2.02 फीसदी की गिरावट दर्ज की, जो 26 अक्टूबर 2018 के बाद का सबसे खराब हफ्ता है। बाजार के प्रतिभागियों ने कहा कि आर्थिक चिंता, पिछले सात कारोबारी सत्रों में निराशाजनक नतीजे और अमेरिका-चीन के बीच कारोबारी तनाव में बढोतरी ने बाजार पर दबाव बनाए रखा।

विशेषज्ञों ने कहा कि 30 जनवरी की बैठक में अमेरिकी फेडरल रिजर्व के रुख में बदलाव और आरबीआई के रुख में 7 फरवरी को आए परिवर्तन के अलावा इस महीने पेश आम बजट ने फरवरी के पहले हफ्ते बाजार की धारणा में सुधार किया था।

एचडीएफसी सिक्योरिटीज के शोध प्रमुख (खुदरा) दीपक जसानी ने कहा, उम्मीद की जा रही थी कि विदेशी पोर्टफोलियो निवेश के लिहाज से बुरे दिन पीछे रह सकते हैं और रुपये में उछाल आ सकती है जबिक बॉन्ड का प्रतिफल घट सकता है, लेकिन ऐसा नहीं हुआ। साथ ही बजट में जताए गए अनुमान खासे आक्रामक रहे और राजस्व व राजकोषीय घाटे का लक्ष्य हासिल करना मश्किल हो सकता है, ऐसे में उल्लास का माहौल जल्द ही समाप्त हो गया।

जर्मनी की वाणिज्यिक वाहन कंपनी डेमलर ने कहा है कि वह बाजार परिस्थितियां अनुकुल होने पर भारतीय बाजार में इलेक्ट्रिक वाहन उतारेगी। कंपनी के एक शीर्ष अधिकारी ने शुक्रवार को यह जानकारी दी। कंपनी के मुख्य कार्याधिकारी एवं प्रबंध निदेशक सत्यकाम आर्य ने कहा, आपको पता है कि डेमलर दुनिया भर में अपने वाहनों के विद्युतीकरण में लगी है। हमें जब लगेगा तो हम भारत में भी यह प्रौद्योगिकी लाएंगे। उन्होंने बताया कि कंपनी ने दुनिया के तीन प्रमुख बाजारों में इलेक्टिक वाहन उतारे हैं। उनको लेकर ऐसी प्रतिक्रिया मिली है जिसकी आप कल्पना नहीं कर सकते। उन्होंने यह संवाददाताओं से कहा कि ये वाहन जापान, यूरोप और अमेरिका में उतारे गए हैं। उन्होंने कहा कि जब आप इलेक्ट्रिक वाहनों की बात करते हैं तो इसमें यात्री कारें, हल्के वाणिज्यिक वाहन, बसें आदि आती हैं, जिनपर काफी काम

कारोबार को अलग करेगी जीएमआर इन्फ्रा

कंपनियों ने बॉन्ड से जुटाए 4.57 लाख कराडु रूपय

घरेलु कंपनियों ने चालु वित्त वर्ष के पहले 10 महीने में व्यापारिक जरूरतों को परा करने के लिए कॉरपोरेट बॉन्ड के निजी नियोजन के जरिए 4.57 लाख करोड रुपये जुटाए हैं। मोतीलाल ओसवाल इन्वेस्टमेंट बैंकिंग के कार्यकारी निदेशक मकंद रंगनाथन ने कहा कि सेबी के कदम से आने वाले समय में बॉन्ड बाजार में और तेजी आने की उम्मीद है। सेबी ने बड़ी कंपनियों से अपने दीर्घकालीन कोष का एक चौथाई हिस्सा बॉन्ड बाजार से जुटाने को कहा है।

अंकेक्षक संग सहयोग न करने पर यूनिटेक को फटकार

आशिष आर्यन नई दिल्ली. 15 फरवरी

फॉरेंसिक ऑडिटरों के साथ सहयोग न करने पर सर्वोच्च न्यायालय ने शुक्रवार को यूनिटेक को फटकार लगाई, जिनकी नियुक्ति अदालत ने की थी और न्यायिक कामकाज में बाधा पहुंचाने के लिए इसके खिलाफ अवमानना की कार्यवाही शुरू करने की चेतावनी दी। इसने कंपनी को सभी आंकडे दो हफ्ते के भीतर उपलब्ध कराने को कहा. जिनकी मांग अंकेक्षकों ने की है।

अदालत की यह टिप्पणी तब आई जब ग्रांट थॉर्नटन के अंकेक्षकों ने अदालत से कहा कि उन्हें अब तक करीब 45 फीसदी वित्तीय व परिचालन के आंकड़े मुहैया कराए गए हैं। यूनिटेक ने सभी इलेक्ट्रॉनिक इक्पिपमेंट की फॉरेंसिक इमेजिंग के लिए आंकड़ा उपलब्ध कराने में असमर्थता जताई थी क्योंकि कंपनी ने कहा कि वह कोई डेटा नहीं रखती। कंपनी ने कहा कि सिर्फ चार प्रमुख अधिकारियों के इलेक्ट्रॉनिक इक्विपमेंट का बैकअप रखा गया था।

दो न्यायाधीशों के पीठ ने इस पर एतराज जताया और कहा कि अनुपालन की जिम्मेदारी यनिटेक की है। पराने कर्मचारियों के डेटा समेत सभी आंकडे जल्द से जल्द कंपनी को उपलब्ध कराना होगा। अदालत ने ७ दिसंबर को युनिटेक की 74 आवासीय परियोजना की फॉरेंसिक ऑडिट का आदेश दिया था, जिसकी जिम्मेदारी ग्रांट थॉर्नटन पर है।

पर अदालत ने यूनिटेक को यूनिटेक पावर ट्रांसिमशन लिमिटेड की बिक्री स्टर्लिंग ऐंड विल्सन प्राइवेट लिमिटेड को करने की प्रक्रिया शुरू करने की अनुमति दी। ग्रांट थॉर्नटन ने इस सौदे की उचित बाजार कीमत 98 करोड रुपये आकलित की है, जिसमें से 68 करोड़ रुपये अदालत की रजिस्ट्री के पास जमा होंगे। साथ ही युनिटेक को हैदराबाद में 24 एकड जमीन 20 करोड़ रुपये में बेचने की भी अनुमति दी। इससे मिलने वाली रकम भी रजिस्ट्री में जमा कराई जाएगी। अदालत ने नोएडा में कंपनी की 186 एकड जमीन बेचने की गुजारिश को ठुकरा दिया और कहा कि फॉरेंसिक ऑडिट कमेटी की रिपोर्ट के बाद वह इस पर विचार करेगी।

भारतीय इक्विटी का मूल्यांकन अभी भी महंगा

भारतीय इक्विटी का मुल्यांकन महंगा बना हुआ है और अप्रैल-मई में आम चुनाव को देखते हुए इसकी रेटिंग में कुछ बदलाव हो सकता है। विदेशी ब्रोकरेज क्रेडिट सुइस ने एक नोट में ये बातें कही है।

बेंचमार्क निफ्टी 12 महीने आगे के 17.1 गुने पीई पर कारोबार कर रहा है जबकि 10 साल का औसत 15.3 है। ब्रोकरेज का कहना है कि इसके बावजूद इक्विटी मार्केट धीरे-धीरे आगे बढ सकता है क्योंकि कंपनियों की आय बढने की संभावना है जबिक आरबीआई ने अर्थव्यवस्था को रफ्तार देने के लिए ब्याज दरों में 25 आधार अंकों की कटौती की है।

क्रेडिट सइस वेल्थ मैनेजमेंट इंडिया के सीएफए और इंडिया इक्विटी रिसर्च प्रमुख जितेंद्र गोहिल ने कहा, तीसरी तिमाही की अब तक की आय अच्छी रफ्तार दिखा रही है. जो और आगे बढ़ सकती है जब आय हस्तांतरण और कम आय वाले समृह के लिए घोषित कर छुट अपना प्रभाव दिखाना शुरू करेगी तो उपभोग में भी इजाफा होगा।

एमटीएन के मुख्य कार्याधिकारी को यूगांडा ने किया निर्वासित

युगांडा ने एमटीएन युगांडा के मुख्य कार्याधिकारी को राष्ट्रीय सुरक्षा से जुड़े मुद्दे को लेकर वापस उनके देश बेल्जियम भेज दिया। एमटीएन यूगांडा दक्षिण अफ्रीका के एमटीएन समूह का हिस्सा है। यह कदम पिछले महीने एमटीएन यूगांडा के तीन वरिष्ठ अधिकारियों को कथित तौर पर राष्ट्रीय सुरक्षा से समझौता करने की योजना बनाने के चलते इस पूर्वी अफ्रीकी देश द्वारा देश से बाहर भेजने की कार्रवाई के बाद उठाया गया है। युगांडा के पुलिस प्रवक्ता फ्रेड एनांगा ने शुक्रवार को इस मामले में विस्तृत जानकारी दिए बिना कहा, 'बेल्जियम के नागरिक विम वनहेलपुट्टे को राष्ट्रीय सुरक्षा से समझौता करने के संदेह में गुरुवार की रात वापस बेल्जियम के लिए रवाना कर दिया गया।'

इस मामले को लेकर एमटीएन यगांडा ने कहा कि वह वनहेलपुट्टे को यहां से वापस भेजे जाने की वजह का पता लगा रही है और अपने मुख्य तकनीकी अधिकारी गोर्डियन क्योमुकामा को कार्यकारी मुख्य कार्याधिकारी नियुक्त किया। रॉयटर्स का वहलेलपुट्टे से संपर्क नहीं हो पाया। कंपनी ने कहा, 'हम इस घटनाक्रम को लेकर गंभीर हैं और अधिकारियों से इस बारे में जानकारी लेने में जटे हैं जिससे हमें इस मामले का समाधान करने में मदद मिलेगी।'

एमटीएन में अल्पांश हिस्सेदारी रखने वाली वेस्टैक्ट पोर्टफोलिया के प्रबंधक माइकल ट्रेहर्ने ने रॉयटर्स को बताया कि विदेशी बाजारों में समूह जिन जोखिमों का सामना कर रहा है उससे शेयर की कीमतें घटी हैं। उन्होंने फोन पर कहा, 'जिन क्षेत्रों में एमटीएन का परिचालन होता है उसकी वजह से बाजार कंपनी

को बहुत बड़ा जोखिम छूट दे रहा है।' नाइजीरियाई केंद्रीय बैंक द्वारा कंपनी पर बिना सही कागजातों के 8 अरब डॉलर की रकम का प्रत्यावर्तन करने का आरोप लगाने के बाद पिछले वर्ष सितंबर में एमटीएन ने 4 अरब डॉलर की बाजार मुल्य गंवाई थी। कंपनी की ओर से टोकन समझौते का भुगतान किए जाने के बाद ही विवाद का समाधान हो सका।

युगांडा का कारोबार समृह की एबिटा मद में 4

फीसदी का योगदान करता है। एक करोड़ से अधिक ग्राहकों के साथ एमटीएन यगांडा देश की सबसे बडी दूरसंचार कंपनी है और इसका मुकाबला मुख्य तौर पर भारत की भारती एयरटेल की स्थानीय इकाई के साथ है। कंपनी पर स्थानीय सराफा में अपने शेयरों को सचीबद्ध कराने का भी दबाव है। कंपनी अपने परिचालन लाइसेंस के नवीकरण के लिए भी लंबी बातचीत में उलझी हुई है। कंपनी का लाइसेंस 20 वर्ष की अवधि के लिए था जो पिछले वर्ष ही पूरा हो गया।

युगांडा संचार आयोग (युसीसी) के कार्यकारी निदेशक गाँडफ्रे मुताबाजी ने रायटर्स को बताया कि सरकार ने एमटीएन के लाइसेंस को आगे बढाने के लिए प्रभावी रूप से निर्णय लिया है। युगांडा के राष्ट्रपति योवेरी मुसेवेनी ने जनवरी के अंत में फिर से एमटीएन युगांडा को अपने शेयर सूचीबद्ध करने की अपील की जिससे कंपनी में स्थानीय हिस्सेदारी हो सके और कंपनी जो पैसा यहां से कमाती है उसका बड़ा हिस्सा देश में ही रहे।

बाजार हिस्सेदारी के लिए बजाज और हीरो के बीच प्राइस वॉर

देश की सबसे बड़ी दोपहिया निर्माता हीरो ने प्राइस वॉर शुरू कर दिया है और आकर्षक छट व योजनाओं पर दांव लगा रही है। अपनी बाजार हिस्सेदारी के लिए यह काम तब हो रहा है जब मोटे तौर पर काफी कम छट मिलती है। इस समय डीलरों के पास काफी ज्यादा इन्वेंट्री हो गई है।

हीरो मोटोकॉर्प ने सोमवार को विज्ञापन प्रकाशित किया है, जिसमें आकर्षक बीमा योजनाओं की घोषणा की गई है, जिसमें खरीदारों को पांच साल का एक्सिडेंट कवर दिया जा रहा है। कंपनी के कदम को बजाज ऑटो से प्रतिस्पर्धा का मुकाबला करने के लिए रक्षात्मक रणनीति के तौर पर देखा जा रहा है। पुणे की प्रतिस्पर्धी बजाज आक्रामक कीमत के जरिए हीरों के एंट्री लेवल मॉडल पर चोट पहुंचा रही है। पिछले साल त्योहारी सीजन शुरू होने से पहले बजाज ने एक योजना पेश की थी, जिसमें खरीदारों को खुद के नुकसान का बीमा, पांच साल की वॉरेंटी और पांच साल के लिए मुफ्त सर्विस शामिल है। रिलायंस सिक्योरिटीज के

विश्लेषक मितुल शाह ने कहा, यह कदम शायद सुरक्षा नियम के चलते उठाया गया होगा, जो एक अप्रैल से प्रभावी होगा और सभी बाइक के लिए एंटी लॉक ब्रेकिंग सिस्टम और कम्बाइंज ब्रेकिंग सिस्टम अनिवार्य बनाता है।

सूत्रों के मुताबिक, हीरो की तरफ से बेचे जाने वाले आधे से ज्यादा मॉडल इन विशेषताओं के बगैर हैं, ऐसे में इस पेशकश के जरिए कंपनी शायद अपना स्टॉक निकालने की कोशिश कर रही है। शाह ने कहा, हमें देखना होगा कि क्या ये योजनाएं अप्रैल के बाद भी जारी रहेगी और अगर ऐसा होता है तो यह वास्तव में प्राइस वॉर है। उन्होंने कहा कि मौजूदा योजना से मार्जिन पर असर पडेगा। हीरो की योजना की जानकारी रखने वाले उद्योग के एक अधिकारी ने कहा, कंपनी की यह कोशिस एंट्री लेवल दोपहिया में अपनी स्थिति को सुरक्षित रखने के लिए है। उन्होंने कहा, जब धारणा कमजोर हो तो बिक्री बढ़ाने के लिए प्रोत्साहन की दरकार होती है। त्योहारी सीजन सुस्त रहा था,

जिससे काफी इन्वेंट्री जमा हो गई। उम्मीद की जा रही थी कि शादी-विवाह के सीजन के चलते जनवरी से स्थिति सुधरेगी, लेकिन ऐसा नहीं हो पाया। साथ ही बीमा की उच्च लागत के चलते बाइक की खरीद लागत बढ़ी है। अधिकारी ने कहा, बीमा लागत अब बाइक की कुल लागत का करीब 10 फीसदी है। इस योजना के साथ हीरो बीमा लागत खुद वहन करने का प्रस्ताव रख रही है। हीरो के डीलर ने कहा, अनिबका स्टॉक औसतन छह हफ्ते का है जबकि सामान्य नियम तीन हफ्ते का होता है। एक डीलर ने कहा, इन्वेंट्री घटाने के लिए हमें इस योजना के तहत बेचने में दिक्कत नहीं है।

दुनिया के सबसे बड़े दोपहिया बाजार में पिछले पांच महीने से बाइक की बिक्री की रफ्तार सुस्त है। फरवरी में देसी दोपहिया की बिक्री पिछले साल की समान अवधि के मुकाबले 5 फीसदी घटी। वहीं स्कूटर व मोपेड की बिक्री साल दर साल के हिसाब से क्रमश: 10 व 5 फीसदी घटी है जबकि मोटरसाइकल की बिक्री लंबे समय के बाद साल दर साल के हिसाब से 3 फीसदी घटी है।
