

पीटीआई, नई दिल्ली : केंद्र ने पर्यावरणीय प्रभाव के आकलन संबंधी नियमों में संशोधन करते हुए नियंत्रण रेखा या सीमा के 100 किलोमीटर के भीतर रक्षा तथा सामरिक महत्व से संबंधित हाइवे प्रोजेक्ट को सीमा को भी बचाया गया है, जो कोयले, पर्यावरणीय मंजूरी की आवश्यकता से छूट देने की घोषणा की। केंद्रीय पर्यावरण मंत्रालय द्वारा जारी अधिसूचना के अनुसार, हवाई अड्डों पर टर्मिनल बनाने के विस्तार (हवाई अड्डे के मौजूदा क्षेत्र में विस्तार के विना) से संबंधित परियोजनाओं के लिए अब अनुमति लेने की जरूरत नहीं होगी। इसमें बायोमास-आधारित बिजली संयंत्रों की छूट सीमा को भी बचाया गया है, जो कोयले, लिग्नाइट या प्रोपेलिंटम उत्पादी जैसे सहायक ईंधन का 15% तक उपयोग करते हैं।
