आइपीएस रिंम शुक्ला का नाम आरोपी के तौर पर नहीं : महाराष्ट्र सरकार

मुंबई, 5 सितंबर (भाषा)।

महाराष्ट्र सरकार ने बंबई उच्च न्यायालय को बताया कि भारतीय पुलिस सेवा (आइपीएस) की वरिष्ठ अधिकारी रिशम शुक्ला का नाम कथित गैर कानूनी फोन टैपिंग और पुलिस के स्थानांतरण और तबादला संबंधी दस्तावेजों को लीक करने के मामले में आरोपी के तौर पर शामिल नहीं किया गया है और इसलिए वह प्राथमिकी रद्द करने की मांग नहीं कर सकती। अदालत में शनिवार को दाखिल हलफनामे में सरकार ने कहा कि जांच का मकसद केवल यह पता लगाना है कि कैसे राज्य खुफिया विभाग से गोपनीय और संवेदनशील जानकारी गैरकानुनी तरीके से तीसरे पक्ष तक पहुंची और इसका दस्तावेज की सामग्री से कोई लेना देना नहीं है।

सरकार ने दावा किया कि यह अपराध राज्य के पूर्व गृहमंत्री अनिल देशमुख पर लगे आरोपों की चल रही केंद्रीय अन्वेषण ब्यूरो (सीबीआइ) की जांच से संबद्ध नहीं है। शुक्ला ने अपनी याचिका में प्राथमिकी रद्द करने का अनुरोध करते हुए आरोप लगाया है कि पुलिस स्थानांतरण और तबादले में कथित भ्रष्टचार उजागर करने की वजह से उन्हें महाराष्ट सरकार द्वारा बलि का बकरा बनाया जा रहा है और उन पर निशाना साधा जा रहा है।

हिमाचल, उत्तराखंड में कुछ दिन भारी बारिश की संभावना

इसी तरह अगले तीन दिन के दौरान कर्नाटक, तमिलनाडु और केरल में अलग-अलग जगहों पर भारी से बहुत भारी बारिश होने की संभावना है और इसके बाद तीव्रता में कमी आएगी। भारत के मौसम विज्ञान

विभाग ने कहा कि उत्तर मराठवाडा, उत्तर मध्य महाराष्ट्र, उत्तरी कोंकण और गुजरात के क्षेत्र में सात-नौ सितंबर के दौरान वर्षा होने की संभावना है। वहीं, सात-आठ सितंबर के दौरान उत्तरी कोंकण में, आठ सितंबर को मध्य महाराष्ट्र और गुजरात क्षेत्र में और सात सितंबर को तेलंगाना में अलग-अलग स्थानों पर अत्यधिक भारी वर्षा हो सकती है।

पुलिस की जांच में अयोध्या जिले के रहने वाले डॉ रजनीश सिंह का नाम सामने आया और उनके खिलाफ साक्ष्य मिलने पर अदालत से गैर जमानती वारंट एवं कुर्की की कार्रवाई के लिए आदेश भी प्राप्त कर लिया गया था।

जम्मू कश्मीर में दसवीं, बारहवीं की कक्षाएं शुरू होंगी

जम्मू, ५ सितंबर (भाषा)।

जम्मू-कश्मीर प्रशासन ने रविवार को कुछ शर्तों के साथ कक्षा 10वीं और 12वीं के छात्रों के लिए उच्च शिक्षण संस्थानों और स्कूलों को फिर से खोलने की अनुमति दे दी। यह निर्णय मुख्य सचिव एके मेहता की अध्यक्षता में हुई बैठक में लिया गया। रात के कर्फ्यू सहित अधिकांश कोविड-19 नियंत्रण दिशानिर्देशों को बनाए रखने का भी निर्णय लिया गया। कोविड-19 के प्रसार को रोकने के उद्देश्य से उपायों के तहत जम्मू कश्मीर प्रशासन ने 18 अप्रैल को अगले आदेश तक विश्वविद्यालयों और कॉलेजों सहित सभी शैक्षणिक संस्थानों को बंद करने का आदेश दिया था। कोविड-19 स्थिति

की समीक्षा के बाद जारी एक आदेश में, राज्य कार्यकारी समिति (एसईसी) के अध्यक्ष मेहता ने कहा कि 12 वीं कक्षा के छात्रों के लिए कक्षाओं के लिए मंजुरी इस शर्त पर होगी कि किसी भी दिन भौतिक मौजूदगी कुल क्षमता का 50 प्रतिशत से अधिक नहीं होगी। आदेश में कहा गया है, 'स्कूल आने के इच्छुक सभी छात्रों के माता-पिता से सहमित प्राप्त करनी होगी। स्कूल परिसर को पूरी तरह से सेनेटाइज किया जाना चाहिए, स्कूल के गेट पर टीकाकरण के संबंध में उचित जांच की जानी चाहिए। अगर कोई छात्र या शिक्षक या अन्य स्कूल कर्मचारी में खांसी, सर्दी, या बुखार के लक्षण दिखता है, तो उन्हें स्कूल में प्रवेश करने की अनुमित नहीं दी जाएगी।
