

MBL Infra update on Arbitration award

The Hon'ble Arbitral Tribunal comprising of Hon'ble Justice A K Sikri, Former Judge Supreme Court of India, Presiding Arbitrator, Hon'ble Justice Reva Khetrupal, Former Judge High Court of Delhi, Co-arbitrator and Hon'ble Justice Alok Kumar Singh, Former judge Allahabad High Court, Co arbitrator has unanimously passed award dated 03.04.2023 against NHAI for the completed project of construction of residential accommodation for NHAI staff at Pocket B-5, Sector 17, Dwarka, New Delhi. The net amount receivable in terms of the arbitration award is Rs 26.73 crores plus further interest of 10% p.a. from date of award till the date of payment.
