#### Dear Sir,

- 1. I, Akshay S Pachlag, Company Secretary in Practice, Hubballi, was appointed as the scrutinizer by the Board of Directors of the Company at their meeting held on 15<sup>th</sup> September 2022 for the purpose of scrutinizing e-voting process (remote e-voting) and postal ballot forms under the provisions of Section 108 and 110 of the Companies Act, 2013 (the Act) read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended (Rules), on the resolutions contained in the Notice for the postal ballot dated 24<sup>th</sup> September 2022.
- 2. The Company had availed the remote e-voting facility offered by Kfin Technologies Limited for conducting the e-voting process by the shareholders of the Company. The Company had also provided voting by the Postal Ballot Form along with prepaid postage Business Reply Envelope to the Shareholders of the Company.
- 3. The Equity Shareholders holding shares as on 24th September 2022, being cut-off date, were entitled to vote on the resolutions mentioned in the Notice of the Postal Ballot.
- 4. The management of the Company is responsible to ensure Compliance with the requirement of the Companies Act, 2013 and Rules relating to voting through remote e-voting and by postal ballot form for the resolutions contained in the Notice for the postal ballot dated 24<sup>th</sup> September 2022. My responsibility as a scrutinizer for the voting process of e-voting through electronic means is restricted to furnish scrutinizer's report on the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system provided by Kfin Technologies Limited (Kfin), the Agency authorized under the Rules and engaged by the Company to provide remote e-voting facilities for the voting through electronic means and postal ballots received by me respectively.
- The remote E-Voting period remained open from 9.00 AM on Saturday, 1<sup>st</sup> October, 2022 to 5.00 PM on Sunday, 30<sup>th</sup> October, 2022.
- 6. The votes cast through physical ballots form received before 5.00 PM on Sunday, 30<sup>th</sup> October, 2022 were considered and no postal ballot forms were received after the cut off time.
