

प्रारंभिक जांच के मुताबिक नियुक्ति पत्रों पर सचिवालय के विशेष प्रशासन विभाग (एसएडी) के अधिकारी के फर्जी हस्ताक्षर थे। पुलिस के मुताबिक गत दिवस पालमपुर के पारस चपरासी और क्लर्क के लिए अजय नौकरी ज्वाइन करने सचिवालय पहुंचे थे। उन्होंने अधिकारियों को नियुक्ति

अस्पताल के आरकेएस कर्मियों की हड़ताल के चलते मरीजों की कंप्यूटरकृत पर्चियां नहीं बन पाईं। इस दौरान पर्चियां बनाने का काम दूसरे कर्मियों को सौंपा गया लेकिन हाथों से पर्चियां बनाने के कारण काउंटरों पर लंबी लाइनें लगी रहीं। इसके अलावा दाखिला फार्म भरने और टेस्ट फीस जमा करवाने के कार्य भी प्रभावित रहे। आईजीएमसी में रोजाना हजारों मरीज उपचार के लिए आते हैं लेकिन सुबह आठ बजे सैकड़ों आरकेएस कर्मी हड़ताल पर चले गए।आरकेएस कर्मी सुबह आठ से दोपहर 12 बजे तक हड़ताल पर रहे। अस्पताल में शाम तक 1158 मरीजों ने उपचार करवाया। इनमें 1039 मरीज जनरल और 119 मरीज आपात स्थिति में उपचार

आईजीएमसी के न्यू ओपीडी स्थित सैंपल क्लेक्शन सेंटर पर निजी क्रस्ना लैब ने मरीजों ने सैंपल नहीं लिए। अस्पताल प्रबंधन का दावा था कि निजी क्रस्ना लैब हड़ताल के दौरान सैंपल लेगी। लेकिन मंगलवार सुबह न्यू ओपीडी ब्लॉक में स्थिति इसके विपरीत रही, वहीं सरकारी सैंपल क्लेक्शन सेंटर भी खाली रहा।
