# France bans Abayas dress in schools

DIS-FROM PARIS

n Monday, September when French schools and educationalinstitutions will reopen after the summer holidays, students who wear theabaya will no longer be allowed entry into the classrooms. Nearly twentyyears after France banned the display of religious symbols and attires atschool, the new French Minister of National Education, 34-year-oldGabriel Attal declared, "No longer (anyone) be able to wear the abaya atschool," on the TF1 TV channel last Sunday. So, what is the abaya really? The abaya, meaning "coat" in Arabic, is a traditional garment worn in-Saudi Arabia, the Persian Gulf and some countries of the Maghreb. Ithas a neutral hue, is loose and light and is worn from the shoulders to the feet and does not cover the face or head. It is similar to the djellabain North Africa or the qamis in west Africa.

Why an abaya ban now? More and more educational establishments have been reporting attackson the fundamental French principle of laïcité, a kind of secularismquintessential to the country's identity and history. They have also beenasking for clarification when it comes to clothing in educational institutions with respect to this very laïcité.

#### **EVOLUTION OF BANS ON RELIGIOUS SIGNS, SYMBOLS AND GARMENTS IN FRANCE**

1800s: Laws did away with all traditional Christian influence from publiceducation

March 15, 2004: a law prohibiting the wearing or display of religioussigns, symbols or clothes in public schools was promulgated. Thus, notonly is the Islamic veil banned in a school enclosure, but so are the Jewish yarmulke, Sikh turbans or large Christian Crucifixes. However, abayas weren't mentioned

October 2010: Total ban on full-face coverings such as the burqa andniqab in public spaces and a fine of €150 as punishment for the lawbreakers.

In a three-page note, produced by State Services and which the Frenchdaily, Le Figaro obtained, it was said that 2022-2023 school yearwas marked by a sharp increase in the number of reports of attacks onsecularism and high incidences of the wearing of and the display ofreligious symbols and outfits that were infringing the law of March 15,2004."According to this note, 4,710 reports of attacks on secularism werereported during the 2022-2023 school year, compared to 2,167 in 2021-2022. At least 150 establishments have to deal with the phenomenon ofabayas, which sometimes turns out to be massive. Apart from the phenomenon of abayas, attacks on secularism inschools, notably, teaching challenges, verbal provocations, suspicions ofproselytism, refusal to do school activities, etc. are increasing significantly.
