The matter was then reported to the Audit Committee which confirmed the violation of Code of Conduct formulated pursuant to SEBI (Prohibition of Insider Trading) Regulations, 2015 by Mr.Uday Balaji and issued a warning letter to him and prohibited him from selling the shares for a period of 1
