वरसावे पूल पुन्हा अवजड वाहनांसाठी बंद

मानखुर्दमध्ये प्लास्टिक गोडाऊनला भीषण आग

मीरा रोड : भाईदर खाडीवरील वरसावे पुलाच्या दुरुस्तीचे काम महामार्ग प्राधिकरणकडून हाती घेण्यात आले आहे. या काळात १३ ते १५ नोव्हेंबरदरम्यान खाडीपूल अवजड वाहनांना वाहतुकीसाठी बंद असणार आहे.

गोडाऊन आहेत. तसेच या परिसरात लोकवस्ती देखील दाट आहे. प्लास्टिकच्या गोडाऊन आग लागल्यानंतर थोड्याच वेळात आगीने रैद्यरूप धारण केले. आग पसरल्यास या भागात मोठे नुकसान होण्याची शक्यता असल्याने नागरिकांमध्ये भीतीचे वातावरण पसरले होते. नागरिकांनी घटनेची माहिती अग्निशमन दलाला देताच अग्निशमन दलाचे जवान घटनास्थळी दाखल झाले, सध्या आगीवर नियंत्रण मिळवण्याचा प्रयत्न सुरू आहे.
