Subject: Scrutinizer's Report

I, M. Damodaran, Managing Partner of M Damodaran & Associates LLP, Practicing Company Secretaries had been appointed as a Scrutinizer by the Board of Directors of **THE FEDERAL BANK LTD** ("the Bank") for the purpose of Scrutinizing the process of postal ballot by means of electronic voting only ("Voting through Electronic means or remote e-Voting"), in a fair and transparent manner, under the provisions of Section 108 & 110 of the Companies Act, 2013 ("the Act") read with Rule 20 & Rule 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules") read with relevant circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India in this regard, for ascertaining the requisite majority on voting in respect of the following resolutions as set out in the postal ballot Notice;

- a) **Special Resolution** for re-appointment of Mr. Siddhartha Sengupta (DIN: 08467648) as an Independent Director of the Bank.
- b) **Special Resolution** for re-appointment of Mr. Manoj Fadnis (DIN: 01087055) as an Independent Director of the Bank.
- The Management of the Bank is responsible to ensure the compliance with the requirements of the Act and Rules made thereunder including the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India relating to evoting for the resolutions as set out in the postal ballot notice dated Thursday, March 28, 2024. My responsibility as a Scrutinizer was to ensure that the remote e-voting process is









conducted in a fair and transparent manner and render Scrutinizer's Report of the total votes casted "in favor" or "against", if any, on the resolutions stated in the postal ballot notice, based on the report generated from the e-voting system provided by M/s. National Securities Depository Limited (NSDL), engaged by the Bank to provide e-voting facility.

- 2. The Bank has on Wednesday, April 17, 2024, sent the postal ballot notice in electronic form in accordance with the relaxation granted by the Ministry of Corporate Affairs (MCA) vide General Circular No. 09/2023 dated September 25, 2023 to its Members whose name(s) appeared on the Register of Members/ list of beneficiaries as on Friday, April 12, 2024 (cut-off date). The said postal ballot notice contained the procedure for remote e-Voting by members as required under the Act, Rules and applicable regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- 3. In accordance with the postal ballot notice dated Thursday, March 28, 2024 dispatched to Members by electronic mode on Wednesday, April 17, 2024 and the 'Advertisement' pursuant to the Rules published on Thursday, April 18, 2024 the remote e-Voting commenced at 09:00 am (IST) on Friday, April 19, 2024 and ended at 05:00 pm (IST) on Saturday, May 18, 2024.
- 4. The Members holding shares as on Friday, April 12, 2024, i.e., cut-off date, were entitled to vote on the resolutions stated in the postal ballot notice.
- 5. The votes were unblocked at 5.01 pm (IST) on Saturday, May 18, 2024 in the presence of Mr. K. Janakiraman and Mr. D. Sampath Kumar, who are not in the employment of the Bank and the e-Voting data/results were downloaded from the e-Voting website of NSDL (www.evoting.nsdl.com).
- 6. The downloaded remote e-Voting data/results were scrutinized and reviewed, the votes were counted, and the results were prepared.
- 7. Based on the data downloaded from NSDL e-Voting system, the total votes cast in favor or against the resolutions proposed in the postal ballot notice are as under:
