We, Godrej Agrovvet Limited ("the Company") are pleased to inform you that the Certificate with respect to the Tax Deducted at Source ("TDS") on Final Dividend paid by the Company for the Financial Year 2022-23, as declared by the Shareholders at their 32<sup>nd</sup> Annual General Meeting (AGM) of the Company held on **Tuesday, August 1, 2023**, has been made available for you to download from the Company's website.

The Shareholders were informed that, in terms of the provisions of the Income Tax Act, 1961, as amended by the Finance Act, 2020, dividend income is taxable in the hands of Shareholders with effect from April 1, 2020 and the Company was required to deduct TDS from the Final Dividend paid to its Shareholders, at the prescribed rates.

Accordingly, the Company has deducted TDS from the Final Dividend paid to its Shareholders for the Financial Year 2022-23 (payment made during the Financial Year 2023-24), wherever applicable, at the appropriate rates and thereafter duly filed TDS Returns and generated TDS Certificates of Shareholders in the prescribed Form 16A (pertaining to the Assessment Year 2024-25).
