PRESS RELEASE – ANNUAL FINANCIAL RESULTS OF THE COMPANY AS OF 31.03.2022

- *We have shown encouraging results for the Q4 21-22 backed by increased sales of our brands across our key markets and normalcy in operations.*
- *For the Q4 21-22, our consolidated total income stood at Rs.146 crores against Rs. 109 crores in the Q4 20-21 showing a growth of 34%.*
- *Our Consolidated EBIDTA was at Rs. 11.71 crores for the Q4 21-22 as against an EBIDTA of Rs.9.15 crores in Q4 20-21 reflecting a growth of close to 28%.*
- *Our Consolidated PBT for the Q4 21-22 stood at Rs. 3.69 crores against the Rs. 32 lakhs for the Q4 20-21 showing a growth of 1050%.*
- *Similarly, our Consolidated PAT for the Q4 21-22 stood at Rs.6.39 crores as against a PAT of Rs. 3.7 crores in Q4 FY 20-21 showing a growth of 77%.*
- *We are hopeful of catching the whole season after being hard due to COVID 19 in the Q1 of the last two financial years.*
