REPORT OF SCRUTINIZER

I. B. Krishnamoorthi, BSc, FCA Practicing Chartered Accountant, Coimbatore was appointed by the Board of Directors of the Company at their meeting held on 10th August, 2019 to act as Scrutinizer for the 31st (Thirty First) Annual General Meeting of the Equity Shareholders of "Ambika Cotton Mills Limited" held on 27th September 2019 at 12.00 Noon at The Residency, Avanashi Road, Colmbatore 641018 for the purpose of scrutinizing the E-Voting process and Physical Ballot voting at the venue in a fair and transparent manner and ascertaining the requisite majority on E-Voting and Physical Ballot voting at venue carried out as per section 108 of the CompaniesAct, 2013 and rule 20(4) (xii) of the Companies (Management and Administration) Amendment Rules, 2015 on the resolutions referred to in this report.

I submit my report as under:

- 1. The Notice was sent to all the Members, whose names appeared in the Register of Members as on 23rd August, 2019 to vote on the proposed 6 (Six) Resolutions as mentioned in the Notice of the Annual General Meeting of "Ambika Cotton Mills Limited" (Item No.1 (One) to 6 (Six) of the Notice of Annual General Meeting of Ambika Cotton Mills Limited. The Members holding equity shares as on the cut-off date i.e. 20th September, 2019 were only considered for e-voting and for voting at the meeting venue. Number of shareholders as on cut-off date is 11304.
- The E-Voting period remained open from 09.00 AM on Tuesday 24th September, 2019 up to 05.00 PM on Thursday 26th September, 2019.
- 3. The Chairman, at the Annual General Meeting, at the end of discussions on the Resolutions contained in the Notice, allowed voting at the venue of the Annual General Meeting on the Ballot Forms provided at the Meeting venue to all those members who were present at the Meeting but have not cast their votes by availing the remote e-voting.

- 4. After the conclusion of the Meeting, the Ballot Boxes were opened in my presence and the physical ballot forms were diligently scrutinized and reconciled with the records maintained by the Registrar and Transfer Agents of the Company. I thereafter first counted the votes cast at the Meeting through these Ballot Forms.
- The Votes cast through E-Voting were unblocked on 27th September, 2019 around 3.00 PM in the
 presence of two witnesses, namely Mr.K. Jayakumar and Mr.R. Sasidharan, who are not in employment of
 the Company.
- In tune with the Instructions for e-voting, sent along with the Notice of the Annual General Meeting dated 10th August, 2019, in respect of members who have voted in both modes (i.e. E-Voting and Physical Ballot form voted at the venue), I have considered only E-Voting by not reckoning the voting done through Physical Ballot Form.
- Six Ballot Forms involving 266 shares which were incomplete and / or otherwise defective were treated as invalid.
- I have collated the votes cast through remote e-voting and votes cast through physical ballot forms at the venue, and the same have been furnished hereunder.
