Dear Sir,

Pursuant to resolution passed by the Board of Directors of the KATARE SPINNING MILLS LIMITED (hereinafter referred to as "the Company") held on 07<sup>th</sup> October, 2021, we have been appointed as Scrutinizer to scrutinize the process of e-voting for postal ballot and to receive, process and scrutinize the postal ballot forms, in respect of special resolution as circulated in the postal ballot notice dated 07<sup>th</sup> October, 2021.

The management of the Company is responsible for ensuring compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronics means and physical postal ballot forms on the resolutions contained in the Postal Ballot notice dated 07th October, 2021.

Our responsibility as a scrutinizer for the voting process is restricted to make a scrutinizer report of the votes cast "in favor" or "against" the resolution based on the postal ballot forms submitted by the shareholders of the Company and on the reports generated from the e-voting system provided by M/s. Link Intime India Pvt Ltd. (through CDSL), the authorized service provider, for extending the facility of electronic voting to the shareholders of the Company.

We issue this combined scrutinizer report in respect of e-voting for postal ballot along with votes casted through postal ballot forms. The result of e-voting along with Postal Ballot forms is annexed with reports as on Annexure1.

## Accordingly, we submit our report as under:

- 1. As confirmed by the Company, the Company has completed the dispatch of Notice on 11.10.2021, to the members whose names appeared in the Register of members as on cut-off date i.e. 01.10.2021.
- 2. The Company has issued a Public Advertisement for notice to the Members of the Company in two Newspaper namely "Financial Express" (English) having nationwide circulation in English Language and "Tarun Bharat" (Marathi) local circulating Newspaper in Marathi as the principle language of Solapur, Maharashtra on 14th October, 2021.
- 3. The Company has offered voting facility either through e-voting or Postal ballot forms to all the Equity Shareholders who are the shareholders as on the cut-off date.
- The E-voting and voting through Postal Ballot were commenced from 13<sup>th</sup> October, 2021 at 09.00 AM and ended on 12<sup>th</sup> November, 2021 at 05.00 PM.
- 5. The voting cast through E-voting was unblocked on 12th November, 2021 at 6:19 PM in the presence of 2 witnesses, Mr.Ketan Nagdev & Mr.Himanshu Burgul who are not in the emplyoment of the Company.
- 6. Thereafter considering e-voting and voting through Postal Ballot, the combined result of the voting is as per annexure. The detail containing inter alia, list of Equity shareholders, who voted "for" or "against", on the resolution that were put to vote, and whose votes invalis, were generated though the e-voting facility provided by CDSL on the designated website of CDSL i.e. <a href="https://www.evotingindia.com">https://www.evotingindia.com</a> and is based on such report so generated.
- 7. In determining the validity or otherwise of the e-voting/postal ballot forms received, we have adopted the following criteria;
- a. Where the date and place has been left blank, the signed ballot has been treated as valid.
- b. Where the number of shares column has been left blank, we have accounted for the total holding for the purposes of either "Assent" or "Dissent" to the relevant resolution as indicate by the member.
- 8. The Postal Ballot and all other papers relating to postal ballot including voting by electonic means shall be under our safe custody till the

Chairman considers, approves ad sign the Minutes and thereafter the same shall be returned to the Company.

9. We hereby report that the Special Resolutions for to approve the sale of undertaking under Section 180 (1) (a) of Plot of Land and Hotel Building Premises situated at 224, Civil Lines, Solapur-413001 as mentioned in the Notice stands dis-approved due to not getting requisite majority of the members, through E-voting and Postal Ballot.
