Tower (BSE Bldg.), Fort, Mumbai – 400 001, on the below mentioned Resolutions, submit my consolidated report on remote e-voting and voting at the 10th AGM in terms of Section 108 Of the Companies Act, 2013 and Rule 20(4)(xii) of the Companies (Management and Administration) Amendment Rule,2015:

- 1. The Company had provided remote e-voting facility for its members to exercise their right to vote in respect of business to be conducted at the 10th AGM held on Tuesday, September 28, 2021 at 03.00 P.M. the remote e-voting module was kept open during Friday, September 24, 2021 (9:00 A.M.) and ends on Monday 27, 2021 (5:00 P.M.) I was appointed as scrutinizer for the purpose of Scrutinizing the remote e-voting process and ascertaining the requisite majority on remote e-voting carried out as per the provision of section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Amendment Rule, 2015 (The Rule) in respect of business to be transacted at the 10th AGM of the members of the Company.
- 2. The Chairman of AGM allowed poll by Polling papers for all those Members who are present at the general meeting and have not cast their votes by availing the remote E-voting facility.
