Regarding "No increase in Pollution Load" certificate of the Board.

In reference to the above, it is intimated that a meeting of the Technical Committee constituted in compliance of Govt. of India notification no. S.O. 980(E) dated 02/03/2021 was held on 02.11.2023 under the Chairmanship of Member Secretary of the Board to evaluate & examine the report of the industry regarding no increase in Pollution Load with the change in product mix (Addition of 26 New Products) by decreasing the production of Caustic Soda from 800 TPD to 700 TPD.

The recommendations of the Committee have been accepted by the Competent Authority. As such, the certificate regarding "No increase in Pollution Load" for change in the product mix as mentioned above is issued to the industry with the following conditions:

- The industry shall make compliance of observations noted by the officers of the Board as conveyed to the industry vide letter no. 363 date 16.04.2024.
- The industry shall frame SOP for control of fugitive emissions from handing of coal of 2. power plant and submit a copy of the same to the PPCB.
- The industry shall ensure the maintenance of Brine Sludge containing Mercury waste in 3. secured and safe way as per relevant guidelines.
- The industry shall ensure the proper testing of groundwater around the closed/capped 4. waste storage facility quarterly from third party preferably any Govt. Agency.

This issues with the approval of Competent Authority of the Board.
