CERTIFIED TRUE COPY OF EXTRACT OF MINUTES OF THE MEETING OF THE BOARD OF ESSEL PROPACK LIMITED HELD ON 22 AUGUST 2019, AT EP-BOARD ROOM, CORPORATE OFFICE, TOP FLOOR, TIMES TOWER, KAMALA CITY, LOWER PAREL, MUMBAI 400013.

It was informed that as a per the terms of the Share Purchase Agreement executed on 22 April 2019 (the SPA) between Ashok Goel Trust (acting through its trustees Mr. Ashok Goel and Mrs. Kaveeta Goel), Mr. Ashok Goel and Epsilon Bidco Pte. Ltd., the existing promoters and promoters group are required to be re-classified from 'promoter and promoter group' category to 'public' category and accordingly they have submitted the requests in this respect. Copy of the requests were placed before the meeting. It was informed that the 'promoter and promoter group' seeking reclassification have been fulfilling the conditions in this respect and are eligible for reclassification as per the provisions of Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015. The Board has discussed the matter and keeping in view the SPA and requests received was of the opinion to approve the same and recommend the same to shareholders of the Company for necessary approval and then to obtain necessary approvals from the Stock Exchanges and/or authority as may be necessary.

The Board, after discussion, passed the following resolution unanimously.

"RESOLVED THAT pursuant to Regulation 31A and applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015 (the SEBI Listing Regulations) and applicable laws, rules etc, and subject to necessary approvals from the shareholders and the stock exchanges where the securities of Essel Propack Limited (the Company) are listed and statutory authorities, as may be necessary, the consent of the Board of the Company be and is hereby accorded to place before the shareholders the request to declassify or reclassify the status of following persons (for the sake of brevity, referred to as the Ashok Goel Group) from the 'promoter and promoter group' to 'public' category, and the Board hereby recommends the approval of the requests received in this respect and also approves to place the request to change their status and shareholding in the Company from "Promoter and Promoter Group" category to "Public" category in shareholding pattern of the Company, records and/or disclosures, before the shareholders for their approval.
