## HC acquits man sentenced for life, asks state to frame rules on preparing discovery panchnama

EXPRESS NEWS SERVICE AHMEDABAD, SEPTEMBER 5

THE GUJARAT High Court, while acquitting a man sentenced to life imprisonment for the murder of a seven-year old girl in 2012, di-rected the state authorities on Tuesday to prepare guidelines and circulate the same among its police officers on how discovery panchnamas are to be prepared in consonance with two Supreme

consonance with two Supreme Court judgments of 2022. Ruing the prosecution's failure to prove the guilt of the accused beyond reasonable doubt, the HC observed that the "most glaring flawwas the drawing of discovery panchanama".

The division bench of Justice A
S Superhia and Justice M R
Mengedey directed the state legal Mengedey directed the state legal secretary and the director general of police to prepare guidelines/ad-ministrative instructions in the form of circular "intimating all po-lice officers, who are assigned the investigation, to prepare the discovery panchnama, as perthelaw enunciated by the apex court in the cases of Subramanya vs state of Karnataka, 2022... and Ramanand @ Nandlal Bharti vs state of Ultar Pradesh, 2022...".
