## GIST OF THE PROCEEDINGS OF THE 38<sup>TH</sup> ANNUAL GENERAL MEETING OF LUMAX AUTO TECHNOLOGIES LIMITED HELD ON 23<sup>RD</sup> AUGUST 2019

The 38<sup>th</sup> Annual General Meeting (AGM) of the Members of the Company was held on 23<sup>rd</sup> August 2019 at Air Force Auditorium, Subroto Park, New Delhi-110010. The Meeting commenced at 03:00 P.M. and concluded at 04:30 P.M. on the same day.

Mr. Dhanesh Kumar Jain, Chairman of the Company, chaired the Meeting. He welcomed the Members of the Company to the AGM and after ascertaining that the requisite quorum being present, the Chairman called the Meeting to order.

The Chairman informed that the Company had extended e-voting facility to all its shareholders to cast their vote in respect of all resolutions mentioned in the notice, which had started at Monday, 19<sup>th</sup> August 2019 at 09:00 A.M. and had closed at Thursday, 22<sup>nd</sup> August 2019 at 05:00 P.M.

The Board of Directors had appointed Mr. Maneesh Gupta, Practicing Company Secretary as the Scrutinizer to supervise the e-voting and ballot voting (Poll) process.

The Chairman requested the shareholders who have not exercised their votes through e-voting facility, to cast their vote by poll on the following resolutions through the ballot paper:

- Adoption of Audited Annual Accounts for the year ended 31<sup>st</sup> March 2019 and Report of Board of Directors and Auditors thereon.
- 2. Declaration of Dividend on Equity Shares for the year ended 31<sup>st</sup> March 2019.
- 3. Re-appointment of Mr. Sanjay Mehta, who retires by rotation.
- 4. Re-appointment of Statutory Auditors from the conclusion of this Annual General Meeting until conclusion of forty third Annual General Meeting and fix their remuneration.
- 5. Appointment of Mr. Kanchan Kumar Gandhi as an Independent Director.
- 6. Appointment of Mr. Arun Kumar Malhotra as an Independent Director.
- 7. Ratification of remuneration payable to Cost Auditor for the Financial Year 2019-20.

The Members casted their votes on the ballot papers provided to them and deposited the same into the boxes placed at the Meeting. The results will be declared and intimated to the Stock Exchange(s) once the report from the Scrutinizer is received.
