Pak, China among 55 nations to back India's 2-year UNSC seat bid

In a major diplomatic win, India's candidature for a non-permanent seat at the UN Security Council for a two-year term has been unanimously endorsed by the 55-member Asia-Pacific grouping...

India for non-permanent seat of UN Security Council term 2021-2022. The video message thanked all the countries in the Asia Pacific group for endorsing India's candidature. The 55 countries supporting India's candidature include Afghanistan, Bangladesh, Bhutan, China, Nepal, Pakistan, Saudi Arabia, Sri Lanka, Vietnam, etc. Each year, the 193-member General Assembly elects five non-permanent members for a two-year term at the UNSC.

States; two for the Latin American and Caribbean States; and two for Western European and other States. Previously, India had been elected as a non-permanent member of the Council seven times, most recently in 2011-2012 under the leadership of former Ambassador Hardeep Singh Puri. Early this month, Estonia, Niger, St. Vincent and the Grenadines, Tunisia and Vietnam were elected to the Council for a two-year term beginning January 2020. St. Vincent and the Grenadines is the smallest nation ever to secure a seat.

Budget may charge up electric vehicle push

With promotion of clean energy high on government agenda, the Budget is likely to incentivise manufacturing of electric vehicles (EVs) in the country. This is also expected to drive foreign direct investment or FDI into the country.

In line with the government's road map for EVs in the next four years, the Budget may offer investment-linked incentives to manufacturers with respect to capital expenditure incurred for setting up operations, according to officials in the know. "With a clear timeline to switch to clean energy vehicles, we are examining tax incentives to encourage players into the EV segment. Besides operations, investment in technology transfers and R&D will also need to be encouraged," said a government official.

Migration needs to be planned: Chandrasekaran

Tata Sons Chairman N Chandrasekaran said on Wednesday that migration to EVs needs to be planned through a multi-year road map to ensure the entire ecosystem is ready, echoing views of industry peers. "What the government and industry must do is build a multi-year road map, with milestones that could help all the players understand shared objectives, build capabilities and infrastructure and minimise any surprises along the way," he said.

(SEZs), beyond the sunset date of 2020, for a few sectors, including EVs. The move will encourage foreign EV players with expertise to set up manufacturing base in the country and export to rest of the world. It will also aid swifter skill transfer to domestic players. Section 10AA of the Income Tax Act, 1961, provides for tax exemption on profits made from export by a unit set up in an SEZ. The exemptions include deduction of 100 per cent export-related profit for first five years and 50 per cent for the next five years.

US firms find legal ways around Huawei blacklist

American technology companies have resumed selling certain products to Huawei after concluding there are legal ways to work with the Chinese telecom giant in spite of its inclusion on a Trump administration blacklist.

US to delay tariffs
The US is willing to suspend the next round of tariffs on an additional \$300 billion of Chinese imports as Beijing and Washington ready resumption of trade negotiations, said sources. This may be made public after Trump's meeting with Xi in Japan.

US oil for China
Oil-hungry refiners across China ramped up purchases of US crude in May amid an erosion of supplies from sanctions-hit Iran and Venezuela, even as trade tensions rage on between Beijing and Washington.
