1. The audit committee has reviewed these results and the Board of Directors has approved the above results at their meeting held on 13th February, 2021 2. The above financial results have been prepared in accordance with the Indian Accounting Standards ("Ind-AS") as specified under section 133 of the Companies Act, 2013 ("the Act") read with the

Companies (Indian Accounting Standards) Rules, 2015. 3. Subsequent to the outbreak of Coronavirus (COVID -19) and consequential lock down across the country, the operations of the Company were disrupted during the period. However, the Company being into agro-chemical business which was declared as an essential service, the Company was able to start its operations soon. However, worldwide disruptions of businesses and economic slowdown has its eventual impact on the Company. A definitive assessment of the impact is not possible in view of the highly uncertain economic environment and the scenario is still evolving. The Company has evaluated its liquidity position and of recoverability and carrying value of its assets and where the impact assessment was possible to make, the necessary adjustments have been made in the

During the earlier two quarters of the current financial year, the Company had used raw material imported under the Advance Authorisation Scheme in manufacture of goods sold in the domestic market. Therefore, the Company incurred additional liability towards custom duty, Integrated Goods and Services Tax (IGST) plus interest, which aggregated to ₹ 60.45 lakhs (net of input tax credit of ₹ 120.67 lakhs claimed) which was paid in the current quarter. Thus, for the quarter ended 31st December 2020, Cost of material consumed as shown above is more by ₹ 51.09 lakhs and Finance cost

by ₹ 9.36 lakhs. And for the quarter ended 30th September, 2020 the same are lower by ₹ 49.34 lakhs and ₹ 8.95 lakhs, respectively. The Code on Social Security 2020 (Code), which received assent of the President of India, subsumes nine laws relating to social security, retirement and employee benefits, including the Employees Provident Fund and Miscellaneous Provisions Act, 1952 and the Payment of Gratuity Act.1972. The effective date of the Code is yet to be notified and related rules are yet to be framed.
