- The remote e-voting period remained open from 9.00 A.M. IST on Friday, the 25th day of September, 2020 up to 5.00 P.M. IST on Tuesday, the 29th day of September, 2020.
- The shareholders holding shares as on the "cut off" date, i.e. the 23rd day of September.
 2020 were entitled to vote on the proposed 4 (Four) resolutions as mentioned in the Notice dated the 1st day of August, 2020 of the AGM of the Company.
- The Company has also provided e-voting facility at the AGM to enable the shareholders
 attending the AGM through VC / OAVM to cast the votes in case the same has not been
 cast by them through remote e-voting.
- 4.
