

## Karnataka Forest Dept to provide insurance cover to visitors

Karnataka, June 23: In a bid to provide more safety to tourists, Karnataka forest department field officers have been directed to provide insurance cover to visitors at eco-tourism sites in protected areas across the state, according to an order from the office of the principal chief conservator of forest (wildlife). The order copy, accessed by indianexpress.com, was issued by Additional Principal Chief Conservator of Forest (wildlife), Kumar Pushkar on behalf of

PCCF (Wildlife) on June 21. The direction comes amid a similar proposal submitted to the forest department by wildlife conservationist Giridhar Kulkarni. In January this year, Kulkarni wrote the forest department stating, "The State's Eco Tourism sites majorly offer activities like trekking, kayaking, jet ski, birding, banana ride, bump ride, dolphin ride, safari, zip-ride, boat ride, rafting, visit to falls/elephant camps including the proposed ropeway. These activities are run

either by the Karnataka Forest Department and/or by Jungle lodges/ Karnataka Eco Tourism Development Board. However, many of the activities carry a risk for tourists e.g., wild animal attacks, drowning, etc. which may result in accidental deaths, permanent/partial disabilities. In fact, incidents like the Thekkady boat disaster happened in 2009 within the limits of Periyar Tiger Reserve, Kerala underline the importance of safety of visitors at Eco Tourism Sites."


video. The song is all set to rock on the silver screens. It is safe to say that the assets of Leo including posters and songs are living up to the hype.

## 17-foot piece of turkey bacon



Pennsylvania, June 23: A Pennsylvania meat company broke a Guinness World Record by preparing a piece of turkey bacon measuring more than 17 feet long.

Godshall's Quality Meats in Lebanon celebrated National Turkey Lovers Month and the first day of summer on Wednesday by cooking the world's longest piece of turkey bacon.

Ron Godshall, the company's president, said the breakfast item cooked for more than 6 hours in a smokehouse oven measuring 25 feet long and 10 feet wide.

Guinness World Records adjudicator Christine Fernandez then measured the bacon and confirmed it was 17 feet 3/4 inch long, surpassing the goal of 16.6 feet set by GWR.

The turkey bacon was then broken into smaller portions and served at a BLT luncheon hosted by Godshall's. The rest was donated to Lebanon County Christian Ministries.
