SC directs to shift **Tarigami to AIIMS**

NEW DELHI: The Supreme Court on Thursday ordered to shift ailing CPI-M leader Mohammed Yousuf Tarigami, who is under detention in Jammu and Kashmir, to the All India Institute of Medical Science (AIIMS) here, saying that his health is top priority. A bench headed by Chief Justice Ranjan Gogoi also sought the Centre's response on a plea filed by CPI-M General Secretary Sitaram Yechury challenging the detention of Tarigami. Yechury's counsel and senior advocate Raju Ramachandran told the court that during his recent visit to Srinagar, Yechury had found that Tarigami's movement has been restricted and his security vehicles have been withdrawn. Ramachandran stressed to pursue the habeas corpus petition filed in this regard. Yechury on Monday filed an affidavit in the Supreme Court after his visit to the Valley to meet his detained party colleague Tarigami. — Agencies


