In view of appointment of one Whole Time Director with effect from 1st May 2023, BPCL has 5 Whole time Directors, 2 Nominee Directors and 6 Independent Directors. BPCL being a Government Company, appointment of all Directors is made as per nomination from Government of India. Accordingly, BPCL has requested Government of India from time to time for the nomination of one Independent Director.

As the Directors are appointed after receipt of nomination from Government of India, BPCL has no control over the appointment of Directors. Hence, BPCL will be approaching BSE Limited and National Stock Exchange of India Limited for waiver of the above mentioned fines levied on BPCL.
