Hathi and fellow researcher Nikhil Srivastav also say they witnessed several lapses at meetings held to design the survey.

The specific goal of reportinglowopen-defecation levels was communicated clearly by government representatives to Kantar Public - the company contracted to conduct the survey - and by Kantar to the surveyors, the two said. Kantar, owned by advertising giant WPP, did not respond to requests for comment.

Hathi told Reuters the NARSS questionnaire contained leading queries about toilet usage that may have influenced respondents, and the government ignored suggestions aimed at fixing queries. The ministry said it 'categorically dismisses and denies the claims of the two RICE researchers'.
