

(Under Rule 154 of NCLT Rules, 2016)

1. The instant Speaking to Minutes is filed by the Interim Resolution Professional (IRP) seeking rectification in para-3 of the order dated 16.03.2022 passed in CP (IB)/141 (AHM) 2021.
2. The facts in brief are that the Petitioner Company, viz., Agarwal Fuel Corporation Pvt. Ltd., had filed an application under Section 9 of the IBC, seeking initiation of CIRP in respect of the Corporate Debtor, viz., M/s. Shree Rama Newsprint Ltd. Upon filing of the petition and in pursuance thereof, an order of initiation of CIRP of the corporate debtor company was passed by this Adjudicating Authority vide order dated 16.03.2022.

3. Heard Ld. Counsel for the applicant and also perused the record. We are of the view that the rectification as sought by way of the instant application deserves to be granted.

Accordingly, para-3 appearing on page no.13 and 14 of the order dated 16.03.2022 stands rectified to the extent that the words "IBBI/IPA-001/IP-P-101104/2017-18/1190" appearing in 5<sup>th</sup> line of para-3 is substituted by "**IBBI/IPA-001/IP-P-01104/2017-18/11790**"

4. Thus, the rectified para-3 of the order dated 16.03.2022 will read as under:-

3. The Operational Creditor has not proposed the name of the Interim Resolution Professional (IRP). Therefore, this Adjudicating Authority hereby appoints **CA Mr. Pradeep Kumar Kabra, having Registration No. IBBI/IPA-001/IP-P-01104/2017-18/11790 and having e-mail id: ippradeepkabra@gamil.com** to act as an IRP under Section 13(1) (c) of the IBC, 2016.
