Re: Review of CRISIL Rating on the Rs.100 Crore Commercial Paper of Shoppers Stop Limited

Once the instrument is issued, the above rating is valid (unless revised) throughout the life of the captioned Commercial Paper Programme with a maximum maturity of one year.
