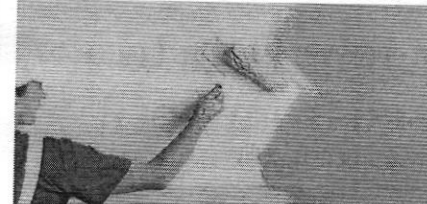

**r of Dulux Paints reported a 5% drop in Q3 profit. Akzo Nobel attributed the fall to a special dividend given in Nov 2023.** Revenue from operations increased by 2% to ₹1,100 crore, while EBITDA rose 2% to ₹1,000 crore. Earnings per share was down 2% at ₹1.00. Subsequently, after ANNV mandated Citi to evaluate strategic options, it decided to sell its Indian operations. Akzo Nobel NV holds a 74.76% stake in Akzo Nobel India. Answering a query on how the news of business restructuring is affecting the morale of employees and distributors, he said: "People realise the outcome may or may not happen...also remember the market cap in India has slightly fallen and it is up to the parent to decide what is the value they see. Our job is to keep the business focussed and you see it in the results."
