Clarification regarding Pledge/Encumbrances on Promoters holdings in DCM Shriram Ltd

New Delhi: Over the last few months there have been some incorrect reports about high level of pledge on shareholdings by the promoters of DCM Shriram Ltd. The NSE also recently decided to include the shares of the company for surveillance due to high level of pledge.

We wish to clarify that the promoters have not pledged any of the shares of DCM Shriram Ltd. This was clarified to the exchanges vide letter dated 12th Nov 2019 and 26th Nov 2019. Further vide letters dated 19th March 2020, the Company and the promoters advised the stock exchanges removal of other encumbrances on the shares. All the promoter shares are free of pledge/encumbrances.

The reports and the actions of the NSE therefore is erroneous.

The company has taken up with NSE to correct the position at the earliest.
