In continuation of our earlier letter dated 5 April 2023 on the captioned subject, we wish to inform you that, in respect of the Issue, the Fund Raising Committee at its meeting held today, i.e., 6 April 2023, approved the issue and allotment of 1,57,15,034 Equity Shares to 57 qualified institutional buyers at the issue price of ₹ 572.70 per Equity Share, i.e. at a premium of ₹ 571.70 per Equity Share, aggregating to ₹ 9,000 million (Rupees Nine Thousand Million), pursuant to the Issue.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up Equity Share capital of the Company stands increased to ₹ 20,37,11,365.00 consisting of 20,37,11,365 Equity Shares of face value ₹ 1 each.
