- 6. Appointment of Scrutinizer to scrutinize the e-voting during the ensuing 26th AGM and remote e-voting process before the AGM in a fair and transparent manner.

In this regard, it may be noted that as per the Company's "Code of Conduct to Regulate, Monitor and Report Trading by Designated Persons and Immediate Relatives of Designated Persons", framed pursuant to the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015, (as amended), the "Trading Window" of the Company shall remain closed for "Designated Persons and their Immediate Relatives" and "Insiders" from 25th August, 2023 to 31st August, 2023 (both days inclusive).
