Sub: Intimation under Regulation 37 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015- Rejection of Application of Scheme of Amalgamation.

This is to inform you that the application of Scheme of Amalgamation between Hybrid Financial Services Limited being the Transferee company and Maximus Securities Limited (Wholly-Owned Subsidiary of Hybrid Financial Services Limited) being the Transferor Company, has been rejected by Office of the Regional Director, Western Region, Mumbai for late filing of Form RD-1 being non-compliance Section 233(1) of the Companies Act, 2013 read with Rule 25(4)(a) Companies Rule, 2016. Sir,

With reference to your application filed vide SRN AA6272575 dated 30/11/2023 and pursuant to the section 233(1) of the Companies Act, 2013 read with Rule 25 (4) (a) of Companies (Compromise, Arrangement and Amalgamations) Rules, 2016 which states that "For the purposes of sub-section (2) of section 233 of the Act, the Transferee Company shall, within seven days after the conclusion of the meeting of members or class of members or creditors or class of creditors, file a copy of the scheme as agreed to by the members and creditors, along with a report of the result of each of the meetings in Form No. CAA.11 with the Central Government, along with the fees as provided under the Companies (Registration Offices and Fees) Rules, 2014. "

However, on examination of your application u/s 233 (1) of the Companies Act, 2013 it is observed that Transferor Company and Transferee Company has filed RD-1 on 30/11/2023 and Extra Ordinary General Meeting of the Transferor & Transferee Companies was held on 15/09/2023 which is not in compliance of said Rule.

Therefore, the captioned application is defective/non-compliant to the mandatory requirements and thus is rejected with liberty to file afresh with due compliance of all the extant requirements of such Section 233 as read with Rules thereunder.

This issues with the Approval of Regional Director, Western Region.
